I. SUMMARY

{¶ 1} The Commission rescinds the certification of the Doug Oberacker facility as an eligible Ohio renewable energy resource generating facility.

II. DISCUSSION

{¶ 2} R.C. 4928.64 and 4928.645 contain the renewable energy resource requirements for electric utility and electric services companies providing electric retail generation in Ohio. R.C. 4928.01(A)(37) defines the types of renewable energy resource generating facilities that qualify in meeting the statutory mandates. Pursuant to Ohio Adm.Code 4901:1-40-04(F), any entity that desires to be designated an eligible renewable energy resource generating facility for the state of Ohio shall file an application for certification that demonstrates the facility satisfies the requirements of R.C. 4928.64 and 4928.645.

{¶ 3} On August 7, 2013, Sol Systems LLC, on behalf of facility owner Doug Oberacker, filed an application to certify the .00245 MW roof mounted solar photovoltaic system on Mr. Oberacker's residence in Valley City, Ohio, as an eligible Ohio renewable energy resource generating facility, as defined in R.C. 4928.01.

{¶ 4} Following approval of the application, certificate No. 13-SPV-OH-GATS-0620 was issued on October 7, 2013.

{¶ 5} On October 19, 2016, Sol Systems LLC filed a letter stating that the Doug Oberacker facility had previously received certification in Case No. 13-2246-EL-REN and

the issuance of Certificate No. 14-SPV-OH-GATS-0023. Accordingly, Sol Systems LLC requested that Certificate No. 13-SPV-OH-GATS-0620 be rescinded.

{¶ 6} Staff filed its review and recommendation on December 29, 2016. Staff recommends that the request to rescind the certificate be granted.

{¶ 7} The Commission finds the request to rescind the duplicate certification of the Doug Oberacker facility to be reasonable. Accordingly, Certificate No. 13-SPV-OH-GATS-0620 should be cancelled.

III. ORDER


{¶ 8} It is, therefore,

{¶ 9} ORDERED, That Certificate No. 13-SPV-OH-GATS-0620 be cancelled. It is, further,


{¶ 10} ORDERED, That a copy of this Entry be served upon all parties of record.


