**MOTION FOR PERMISSION FOR KIMBERLY WHEELER MILLER
TO APPEAR *PRO HAC VICE***

Pursuant to Rule 4901-1-08(B) of the Ohio Administrative Code, Mark R. Orlieb, an attorney for The Ohio Bell Telephone Company d/b/a AT&T Ohio ("AT&T Ohio") licensed to practice law in the State Ohio, respectfully moves for permission for Kimberly Wheeler Miller to appear *pro hac vice* in this proceeding as an attorney for Neustar, Inc. and states that:

1. Rule 4901-1-08(B) of the Ohio Administrative Code permits out-of-state attorneys to practice before the Commission.
2. Paragraph (A)(6) of section 2 of Rule XII of the Rules for the Government of the Bar of Ohio provides as follows:

(6) The attorney may file a motion for permission to appear *pro hac vice* accompanied by a copy of the certificate of *pro hac vice* registration furnished by the Office of Attorney Services, and includes the following information:

- (a) The attorney's residential address, office address, and the name and address of the attorney's law firm or employer, if applicable;
- (b) The jurisdictions in which the attorney has ever been licensed to practice law, including the dates of admission to practice, resignation, or retirement, and any attorney registration numbers;
- (c) An affidavit stating that the attorney has never been disbarred and whether the attorney is currently under suspension or has resigned with discipline pending in any jurisdiction the attorney has ever been admitted;

(d) A statement that the attorney has not been granted permission to appear *pro hac vice* in more than three proceedings before Ohio tribunals in the current calendar year pursuant to Section 2(A)(5);

(e) The name and attorney registration number of an active Ohio attorney, in good standing, who has agreed to associate with the out-of-state attorney.

3. Ms. Miller's residential address is in Arlington, Virginia 22205. She is employed as a Senior Associate General Counsel at Neustar, Inc., and her office address is 1861 International Drive, 6th Floor, McLean, Virginia 22102.

4. Ms. Miller is licensed to practice law in Maryland (Maryland does not issue bar numbers) and the District of Columbia (bar number 461060).

5. Attached to this Motion is an Affidavit of Kimberly Wheeler Miller stating that Ms. Miller has never been disbarred, is not currently under suspension and has not resigned any bar membership with disciplinary proceedings pending against her.

6. Pursuant to Rule XII(2)(A)(5) of the Rules for the Government of the Bar of Ohio, Ms. Miller has not been granted permission to appear *pro hac vice* in any other proceedings before Ohio tribunals in the current calendar year.

7. Mark R. Ortlieb is an active Ohio attorney in good standing, and practices regularly before the Public Utilities Commission of Ohio. Mr. Ortlieb's attorney registration number is 0094118.

8. Ms. Miller received a Certificate of Pro Hac Vice Registration from the Supreme Court of Ohio. A copy of that certificate is attached.

WHEREFORE, Mark R. Ortlieb respectfully requests that Kimberly Wheeler Miller be permitted to practice before the Commission in the above styled proceeding.
