NOTICE OF ASSURANCE WIRELESS PLAN CHANGES

Comes now, Virgin Mobile USA, L.P. ("Virgin Mobile"), and hereby gives notice to the Commission and Staff as required by page 11, paragraph 16 of the Commission's Finding Order dated May 19, 2011 in this docket, of changes in the Assurance Wireless Lifeline plans offered by Virgin Mobile USA, L.P.

First, Virgin Mobile is amending its broadband Lifeline offer to reflect 1 GB of data per month. Existing Lifeline broadband customers will receive this new offer based on their normal service cycle beginning Nov. 10, 2017, with all broadband Lifeline subscribers migrated to the new plan no later than Dec. 1, 2017. New Lifeline broadband customers will receive this offer beginning Nov. 20, 2017. Second, Virgin Mobile is amending its voice-only Lifeline offer to 750 domestic voice minutes and unlimited text messages, effective Nov. 20, 2017.

Virgin Mobile plans to post the new plan information to its website as soon as possible. The changes to Virgin Mobile's plans involve no diminution of benefits. Virgin Mobile is pleased to provide these offerings to Ohio consumers.
