3 ATTORNEY EXAMINER SANYAL: And will  
4 you please just state your name and place of

6 THE WITNESS: My name is Tyler  
7 Teuscher. I work for the Dayton Power and Light  
8 Company as an analyst in the Regulatory

11 ATTORNEY EXAMINER SANYAL: You may  
12 proceed.

13 MR. SCHULER: Thank you, Your Honor.

14 DIRECT EXAMINATION

15 By Mr. Schuler:

16 Q. Good morning, Mr. Teuscher.

17 A. Good morning.

18 Q. You probably heard I had a number of  
19 exhibits marked this morning. I will just  
20 quickly go through them, and starting with the  
21 Joint Exhibit No. 1. Do you have a copy before  
22 you?

23 A. Yes, I do.

24 Q. And do you recognize that document?

25 A. Yes. The document is the

1 Stipulation and Recommendation filed on October  
 2 27th, 2017 in this case.

3 Q. Okay. And do you have before you  
 4 DP&L Exhibit No. 1?

5 A. I do not.

6 Q. I think that's your testimony.

7 A. Okay. Yes, I do have my testimony  
 8 in front of me. DP&L Exhibit 1.

9 Q. Do you have any corrections to your  
 10 testimony?

11 A. I do not.

12 Q. If I asked you the same questions  
 13 today would your answers be the same?

14 A. Yes, they would.

15 Q. And do you have before you a copy of  
 16 DP&L Exhibit No. 2?

17 A. I do not.

18 MR. SCHULER: Let the record reflect  
 19 I just handed the witness a copy of D&L Exhibit  
 20 No. 2.

21 Q. Do you recognize that document?

22 A. Yes, I do.

23 Q. And what do you recognize that to  
 24 be?

25 A. This is the Application in this case

1 filed on June 15th, 2017.

2 MR. SCHULER: All right. Your  
3 Honor, at this time because the stipulation is  
4 unopposed I move for the admission of Joint  
5 Exhibit No. 1 and DP&L Exhibits No. 1 and 2.

6 ATTORNEY EXAMINER SANYAL: Are there  
7 any objections? Hearing none, they will be  
8 admitted.

9 (EXHIBITS HEREBY ADMITTED INTO  
10 EVIDENCE)

11 MR. SCHULER: Thank you. Actually  
12 there is nothing further from the Company, Your  
13 Honor. And we would move for consideration of  
14 the Stipulation and Recommendation by the  
15 Commission.

16 ATTORNEY EXAMINER SANYAL: Is there  
17 any cross-examination of the witness?

18 No? Are there any other matters  
19 that you would like to discuss?

20 MR. PRITCHARD: Yes, Your Honor.  
21 Since we have an unopposed stipulation typically  
22 we waive a briefing schedule. I just wanted to  
23 seek your opinion, Your Honors, guidance on  
24 whether or not briefs would be required.

25 ATTORNEY EXAMINER SANYAL: No briefs

1 shall be required.

2 MR. HEALEY: Your Honor, I would  
3 also ask that as OCC has agreed not to oppose  
4 the settlement in this case, we filed a letter  
5 in the docket and would ask that administrative  
6 notice be taken of OCC's letter stating it's  
7 intention to not oppose the stipulation.

8 ATTORNEY EXAMINER SANYAL: Notice  
9 shall be taken.

10 You are excused. And as there are  
11 no other issues, we are adjourned and the case  
12 is submitted to the record.
