This letter serves as Dominion Energy Ohio's ("Applicant" or "DEO") preapplication notification letter in order for the Ohio Power Siting Board ("Board") to open a case for the proposed US 62-P400148520-STA-62-24.90 (2018) Pipeline Relocation Project in the City of Canton and Plain Township, Stark County, Ohio. This letter is given at least five (5) days prior to DEO's filing of a Construction Notice.

In accordance with Ohio Administrative Code ("OAC") Rule 4906-6-03(A), DEO provides the following information:

**Project Description:** At the request of the Ohio Department of Transportation ("ODOT") DEO is planning to relocate approximately 1,346 feet of 12-inch diameter high pressure pipeline to a public right-of-way provided by the City of Canton ordinance to accommodate ODOT STA 62-24.90 Road Project. DEO will also replace non-jurisdictional smaller pipeline.

**Anticipated Project Schedule:** The construction of the pipeline is anticipated to begin in March 2018. DEO plans to place the line in-service by June 2018.
