

PURPOSE

With this filing, Ameritech Operating Companies (Ameritech) is proposing to detariff Special Access services from Section 21, Metropolitan Statistical Area Access Services, in its F.C.C. Tariff No. 2, as required by the Commission pursuant to FCC Order No. 17-43 (the “*Order*”), released April 28, 2017.

DESCRIPTION

The *Order* requires price cap local exchange carriers to “remove from their tariffs:

- (1) Any packet-based business data service;
- (2) Any circuit-based business data service above the DS3 bandwidth level;
- (3) Transport services as defined in § 69.801;
- (4) DS1 and DS3 end user channel terminations, and all other tariffed special access services, in any market deemed competitive as defined in § 69.801; and
- (5) DS1 and DS3 end user channel terminations, and all other tariffed special access services, in any grandfathered market as defined in § 69.801 for which the price cap local exchange carrier was granted Phase II pricing flexibility prior to June 2017.”

The detariffing must be completed within thirty-six months of the *Order* being published in the Federal Register.

Ameritech hereby proposes to detariff Special Access services from Section 21, Metropolitan Statistical Area Access Services, in its F.C.C. Tariff No. 2. The detariffed service provisions will be available online at www.att.com/guidebook.

21.1 General Description

- (A) This section of the tariff provides the regulations, rates and terms and conditions that apply to telecommunications services provided by the Telephone Company in the Metropolitan Statistical Areas (MSAs) in which the Telephone Company has received Phase II pricing flexibility pursuant to Subpart H of Part 69 of the Commission's Rules. MSAs are divided into the categories below:

(1) Full Service MSAs

Full Service Relief MSAs are those MSAs which qualified for Phase II pricing flexibility for all elements of service, i.e., local channels (channel terminations) between LEC end offices and customer (end user) premises; entrance facilities; dedicated interoffice facilities; local channels (channel terminations) between an interexchange carrier's point of presence and a serving wire center. The Full Service Relief MSAs are set forth in Section 21.2 (A) following.

(2) Limited Service MSAs

Limited Service Relief MSAs are those MSAs that qualified for Phase II pricing flexibility for all elements of service except local channels (channel terminations) between a LEC end office and a customer (end user) premise. The Limited Service Relief MSAs are set forth in Section 21.2 (B) following.

- (B) The services provided in MSAs pursuant to this section of the tariff are set forth in Section 21.3, following. These services are comparable to the SWA Dedicated Transport Services in Sections 6.9.1(D)(12)(a), 6.9.1(D)(12)(b), 6.9.1(D)(12)(c), 6.9.6(A)(1), 6.9.6(A)(6), and (T) 6.9.6(B) ⁽¹⁾. The general regulations, service descriptions and rate regulations for the SWA (D) Dedicated Transport Services in Section 6 ⁽¹⁾ are also applicable to the services specified in (D) this section, except as provided below.

An exception in 21.4(F) applies for term pricing plans.

- (C) Unless otherwise provided for in this section, regulations set forth in Sections 1, 2, 5, 13 and 14 are also applicable.

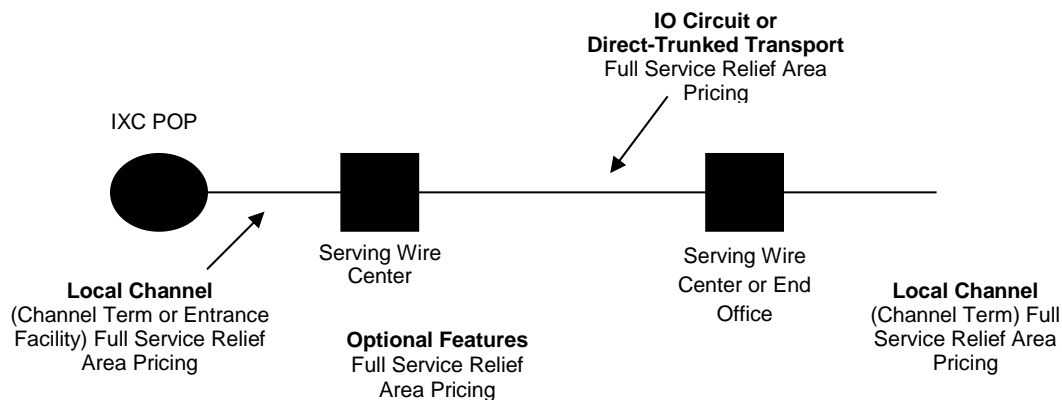

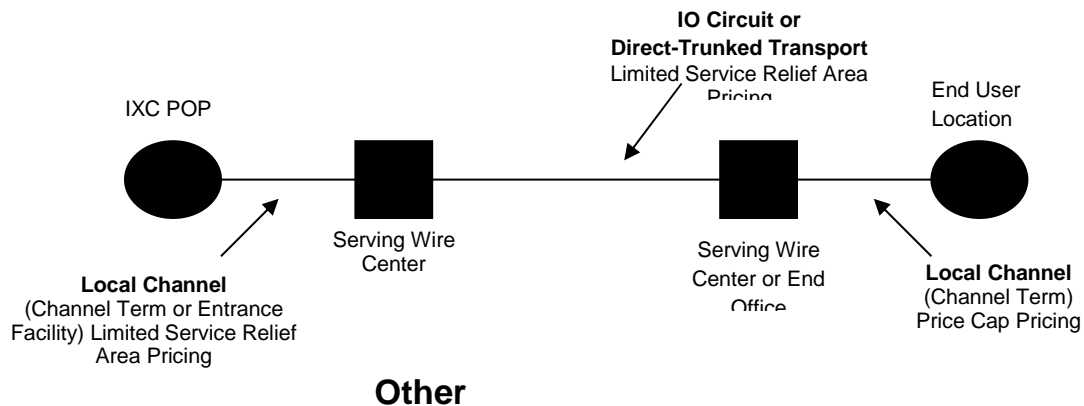

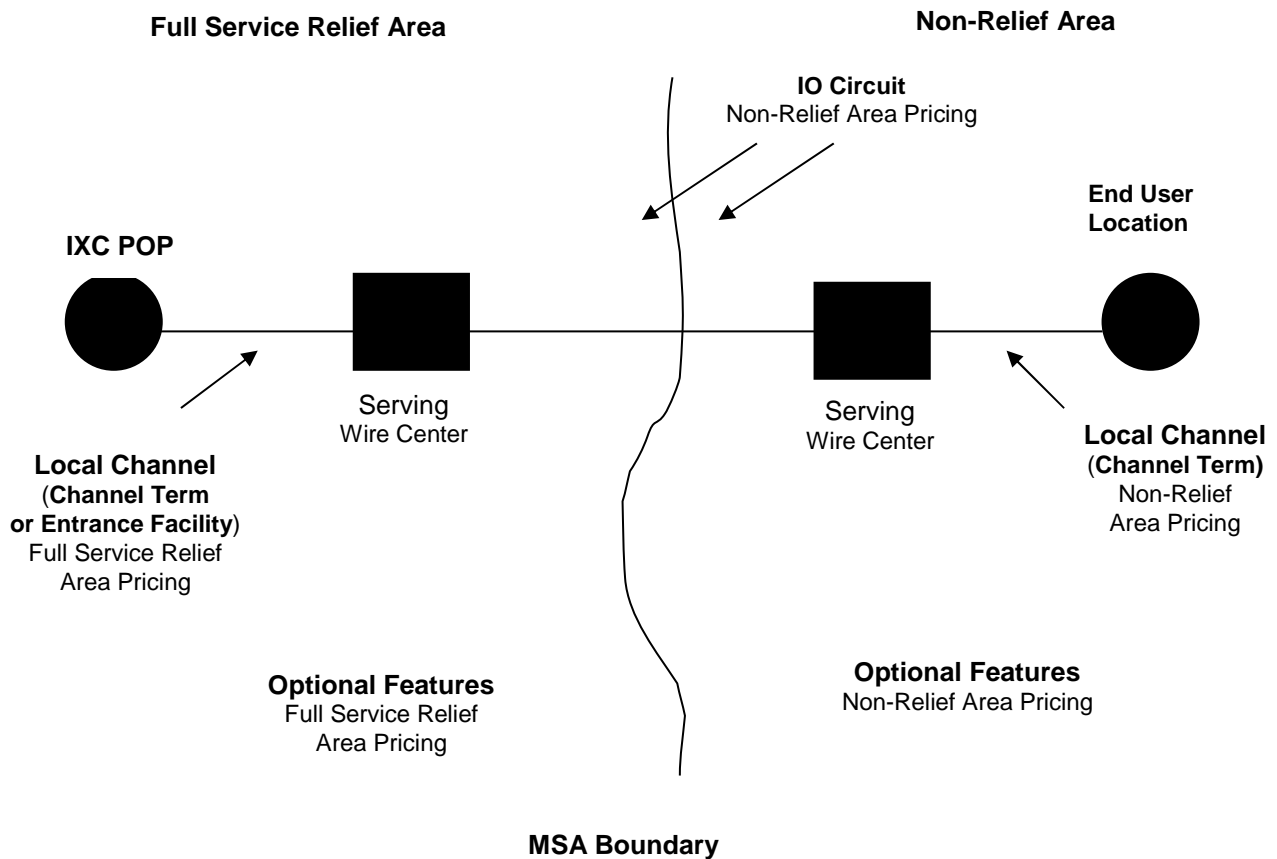

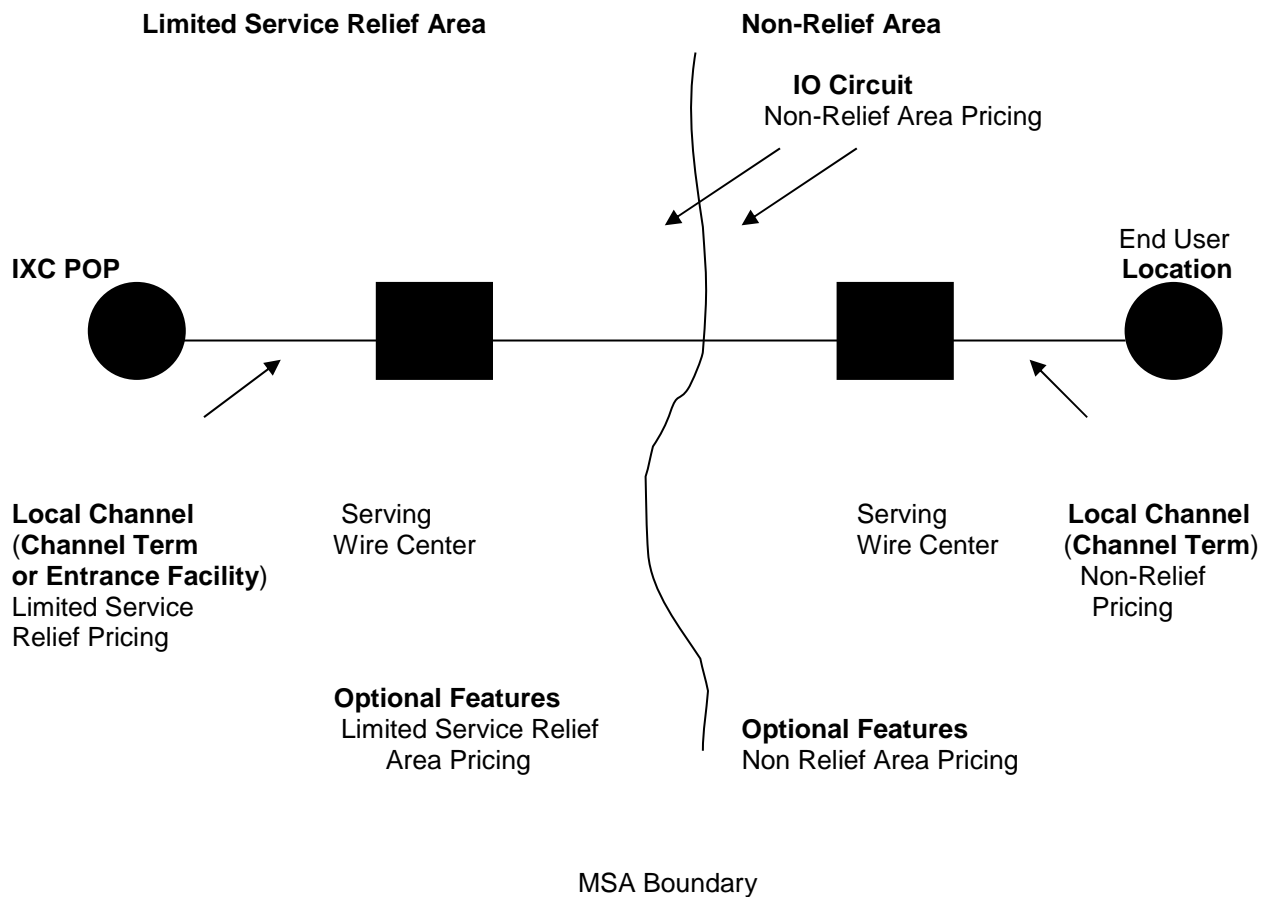
