- {¶ 1} Pursuant to Ohio Adm.Code 4901:2-7-12, Staff served a notice of preliminary determination (NPD) upon Thomas J. Natho (Respondent) alleging a violation of the Commission's transportation regulations.
- {¶ 2} On September 13, 2017, Respondent filed a request for an administrative hearing as permitted by Ohio Adm.Code 4901:2-7-13. A prehearing conference conducted on November 29, 2017, did not resolve the case.
- {¶ 3} Accordingly, the attorney examiner sets this case for hearing on Tuesday, January 30, 2018, at 10:00 a.m., in Hearing Room 11-D at the offices of the Commission, 180 East Broad Street, 11th Floor, Columbus, Ohio 43215-3793.
- {¶ 4} At the evidentiary hearing, Staff must prove that Respondent committed the violation alleged in the NPD by a preponderance of the evidence. Ohio Adm.Code 4901:2-7-20. Following Staff's presentation of the evidence, Respondent will have the opportunity to present testimony and other evidence supporting his contentions regarding the alleged violation in this matter.
- {¶ 5} Pursuant to Ohio Adm.Code 4901:2-7-14, a respondent who has requested an administrative hearing and fails to appear for the evidentiary hearing shall be in default. A respondent in default shall be deemed to have admitted the occurrence of the violation charged and to have waived all further right to contest liability for the forfeiture proposed in the NPD.
