**Letter of Notification  
Duke Energy Ohio 5680 - 138kV Nickel to Warren Rebuild**

Dear Public Official:

Duke Energy Ohio, Inc., has submitted a Letter of Notification to the Ohio Power Siting Board regarding the planned replacement and construction of an approximately 5.78 miles of 138 kV transmission line between the existing Nickel Substation to the Warren Substation located in the City of Monroe and Turtle Creek Township, Warren County, Ohio. The Letter of Notification submittal is required in accordance with Chapter 4906 of the Ohio Administrative Code (O.A.C.). The proposed project area consists of approximately 5.48 miles of existing 180-foot wide Duke Energy transmission line corridor Right-Of-Way (ROW) and approximately 0.3 miles of new 100-foot wide ROW. The Project comprises the replacement of sixty-six (66) galvanized steel (including single-pole, double-pole and triple-pole) structures. The Project begins at Duke Energy's Nickel Station located south of Hamilton Lebanon Road (OH 63), north and west of Union Road, and southeast of Gateway Boulevard (39.426745, -84.431482) and terminates at Duke Energy's Warren Station located southwest of Turtle Creek Union Road, north of Kingsview Road, and east of Lebanon Countryside Trail (39.403683, -84.228060).

In accordance with Ohio laws and regulations, we are required to prepare this Letter of Notification for the Ohio Power Siting Board and, in compliance with O.A.C. 4906-6-07; we are hereby providing you with an electronic copy, available at the following website: <http://dis.puc.state.oh.us/CaseRecord.aspx?CaseNo=17-2500-EL-BLN>.
