GENERAL RULES AND REGULATIONS
Governing Supply of Chilled Water Service

1. Written Application or Contract Required.

A written application or contract, accepted by the Company, will be required from each customer before chilled water service is supplied. This shall apply whether the supply of service involves a new installation, the unsealing of the service valve where service has been previously supplied, or a change in building ownership.

2. Deposit or Other Guaranty Required.

The Company may require a cash deposit or other suitable guaranty for the payment of bills for service, as provided for in the laws of Ohio, before chilled water service is supplied. Interest will be paid on cash deposits so made in accordance with statutory requirements.

If at any time due to changed customer circumstances the Company deems any cash deposit or other security to be inadequate or determines that a cash deposit or other security is required, then the customer shall be required to furnish additional cash deposit, or to provide additional or new security or guaranty as authorized by law, and upon failure to do so, the Company shall have the right to discontinue its service.

3. Application of Rates.

The rate schedules of the Company contemplate that service will be supplied to each separate premise as one customer through one meter. Chilled water service used by the same person, firm or corporation, delivered as measured separately, will not be combined and several premises will not be billed as one customer.

More than one meter may be installed and the meters combined for billing purposes when in the opinion of the Company the conditions make such metering installation necessary.

4. Bills and Remittances.

All bills for chilled water service will be rendered monthly and shall be due and payable within ten (10) days from the date appearing thereon. Any late payments will be assessed a 3% late fee and one and one-half percent monthly finance charge after 30 days from the due date. For the purpose of computing bills for service rendered, the period between regular meter readings shall be considered a month.

5. Chilled Water Supply.

Chilled water for space conditioning will be available throughout the entire year. During the period from April 1 to October 31, considered the cooling season, the temperature of the Chilled Water Supply shall not exceed 42°F. The remainder of the year, from November 1 to March 31, the Chilled Water Supply shall not exceed 44°F. The company shall maintain a minimum

Consumption Charge:

For all Ton Hours \$0.38 per Ton Hour

In addition to the above charges, customer bills shall be subject to the Ohio Gross Receipts Tax.

Rate Schedule for Heating Service Customers

The monthly bill for heating service shall be the sum of the following charges:

Steam Charge:

First 100 MLBS	\$1.00/MLB
Next 200 MLBS	\$0.98/MLB
Next 300 MLBS	\$0.96/MLB
Next 400 MLBS	\$0.94/MLB
Next 500 MLBS	\$0.92/MLB
All Over 1,500 MLBS	\$0.90/MLB

Capacity Charge:

All MLBS	\$15.00/MLB

Fuel Charge:

All MLBS	\$4.101/MLB

Capacity charge will be calculated each month based on the higher of 2008 meter reading or the current meter reading whichever is higher for the month to reflect actual demand on the system for their building for normal weather conditions.

All bills for heating service will be rendered monthly and shall be due and payable within ten (10) days from the date appearing thereon. Any late payments will be assessed a 3% late fee and one and one-half percent monthly finance charge after 30 days from the due date.

In addition to the above charges, customer bills shall be subject to the Ohio Gross Receipts Tax.
