{¶ 1} On November 16, 2017, Grand Ridge Energy LLC filed the above-captioned application, pursuant to Ohio Adm.Code 4901:1-40-04(F), for certification as an eligible Ohio renewable energy resource generating facility as defined by R.C. 4928.01(A)(37). According to the application, Grand Ridge Energy LLC is a four phase wind farm located in Marseilles, Illinois. Grand Ridge Energy LLC represents “phase I” and has a nameplate of 99 megawatt (MW). Grand Ridge Energy II LLC represents “phase II” and has a nameplate of 51MW. Grand Ridge Energy III LLC represents “phase III” and has a nameplate of 49.5MW. Grand Ridge Energy IV LLC represents “phase IV” and has a nameplate capacity of 10.5MW. The nameplate capacity of the entire wind farm is 210MW.

{¶ 2} Ohio Adm.Code 4901:1-40-04(F)(2) provides that if the Commission takes no action with respect to an application within 60 days of filing, the application is deemed automatically approved on the 61st day after the date filed.

{¶ 3} Staff has requested that this application be suspended to allow additional time to obtain or review supplemental information to determine whether the facility meets all certification criteria. Therefore, the attorney examiner finds that good cause exists to suspend the 60-day automatic approval process for this application, in order for Staff to further review this matter.

{¶ 4} It is, therefore,

{¶ 5} ORDERED, That the automatic approval process be suspended for this application for certification as an eligible Ohio renewable energy resource generating facility. It is, further,

{¶ 6} ORDERED, That a copy of this Entry be served upon all parties of record in this case.
