Please accept this letter for filing with the Public Utilities Commission of Ohio ("Commission") as a request by The Columbus Grove Telephone Company ("Company") for approval to effectuate a name change in the Company's d/b/a from FairPoint Communications to Consolidated Communications/Columbus Grove.

FairPoint Communications, Inc. previously advised the Commission of the acquisition by Consolidated Communications Holdings, Inc. of FairPoint Communications, Inc., including Ohio operating subsidiaries:

The Columbus Grove Telephone Company  
The Germantown Independent Telephone Company  
The Orwell Telephone Company

The Company requests an Order from the Commission approving a change in the Company's certificated name from The Columbus Grove Telephone Company d/b/a FairPoint Communications to The Columbus Grove Telephone Company d/b/a Consolidated Communications/Columbus Grove, with an effective date of February 19, 2018, and without the necessity of a hearing. This request does not involve any change to the current ownership, management, finances, personnel or telecommunications operations of the Company.

The Company, operating as a local incumbent in the state of Ohio, will continue to be the holder of the operating authorities in Ohio, will continue providing the services, and will be the entity responsible for all regulatory issues. The only change to the corporation as previously certificated by the Commission is to reflect the change in the d/b/a to "Consolidated Communications/Columbus Grove." This new d/b/a is to be reflected in all company references, including all operating authorities granted to the Company by the Commission.

The Company is hereby filing updated Title Pages, bearing the name The Columbus Grove Telephone Company d/b/a Consolidated Communications/Columbus Grove with an effective date of February 19, 2018. This change will not affect the corporate entity actually providing service, any of the terms and conditions of service or any of the service offerings of the Company. There will be no further revisions to the tariff at this time. Customer notice has been provided by Consolidated Communications in advance of the effective date of the revised Title Page, explaining the change in the Company's business name.

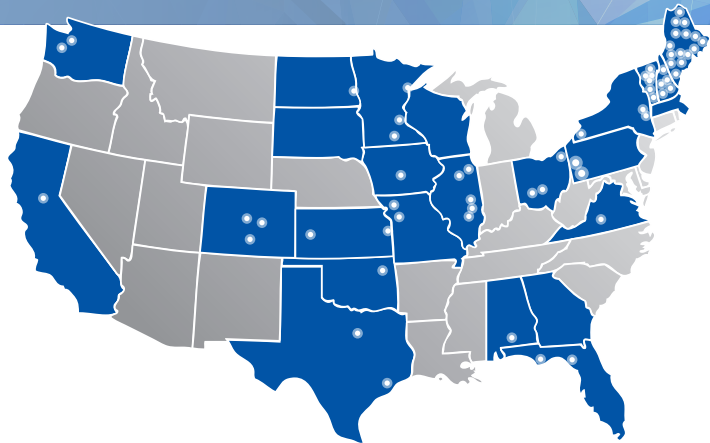


