COLUMBUS, OH – As we look ahead to 2018, this is the time of year when many people make New Year's resolutions. When making resolutions this year, consider setting the goal to spend more time outdoors! If improving health and fitness is on your list of New Year's resolutions, make sure to participate in the winter hikes ODNR is offering throughout the month of January to make the start of this new year great!

- Birds of Winter at Burr Oak State Park – Winter is a great time for bird watching and learning to identify field marks—there are fewer birds, and the trees are bare! We will search for our Ohio winter bird residents on this short hike at Burr Oak State Park on Saturday, Jan. 6, at 10 a.m. Bring binoculars and dress warmly. Meet in the lodge lobby. For more information, call 740-767-3570.
- Water Wise at Shawnee State Park – Acquire new skills or brush up on old ones with Shawnee's naturalist at the lodge indoor pool at Shawnee State Park on Saturdays in January (Jan. 6, 13, 20 and 27) at 10 a.m. Paddling, nautical knots and water safety are the themes of this fun water program. Bring a bathing suit and prepare to get wet. Attend four programs and receive a free hour of kayaking. For more information, call 740-858-6652.
- Nature Nook at Shawnee State Park – Visit with a naturalist at Shawnee State Park and learn more about our native wildlife and fun things to do in the area. Meet upstairs in the lodge from 12-2 p.m. on Saturdays in January (Jan. 6, 13, 20 and 27). For more information, call 740-858-6652.
- Section Hike at Shawnee State Park – Put your feet to the test on a section of the 60-mile Shawnee Backpack trail. Wear sturdy hiking boots, pack snacks and water, and be prepared to climb. Hikers should meet in the lodge lobby of Shawnee State Park on Saturday, Jan. 6, and

- Winter Hike at Lake Hope State Park – Meet at the Hope Furnace on Saturday, Jan. 13, at 10 a.m. for a 3-mile hike on the Peninsula Loop trail to check out the wonders of nature in winter. Dress in layers and wear sturdy boots. For more information, call 740-596-4938.
- Winter Hike at Dillon State Park - Bundle up and join us as we witness the wonders of winter at Dillon State Park on Saturday, Jan. 13. This winter hike is about 2.5 miles long covering the Eagle Ridge Trail and Blackberry Ridge Trail. Deep ravines, rolling hills and beautiful lake views will be waiting. The hike is rated easy to moderate. Hikers are free to hike on their own, and naturalist-guided hikes will start at 11 a.m. and 1 p.m. Meet at the camp store to participant. This is a fantastic way to prepare for the Hocking Hills winter hike. There will be a fire in the camp store's fire ring. The camp store will be open, and coffee and hot chocolate will be available. - Off the Beaten Path at Burr Oak State Park – This winter hiking series will explore areas of the park not normally seen by hiking established trails. Wear sturdy footwear and be prepared for steep hills and uneven terrain on this 2-mile hike at Burr Oak State Park on Saturday, Jan. 13, at 2 p.m. Meet at the nature center. - Winter Hike at Mohican State Park - Winter is an excellent season to see native wildlife, birds and majestic trees while hiking. The winter hike at Mohican State Park will be held on Sunday, Jan. 14, starting at 10 a.m. The hike begins at the commissary, which is located at the park's Class A campground, just south of Loudonville on State Route 3 in Ashland County. Hikers will be able to choose to do three general hikes - a 5K, a longer 10K and an interpretive hike led by a park naturalist. Trails run from moderate to difficult. 
AEP Ohio Schedules Open House to Discuss

Electric Transmission Line

AEP Ohio, a unit of American Electric Power (AEP), and the AEP Ohio Transmission Company Inc. invite residents of Jackson County to attend a public informational open house regarding plans to upgrade an electric transmission line in Liberty and Coal townships in Jackson County. The proposed Coal Township 138 kV Transmission Line Rebuild Project is part of the overall Jackson-Ross County Area Improvements Project where AEP Ohio plans to improve the reliability of the electric transmission grid by updating aging infrastructure to improve its condition and address performance issues.

To learn more about this project, the public is invited to attend a project open house on Thursday, January 25 at Northview Elementary School located at 11507 Chillicothe Pike in Jackson. Doors open at 5:30 p.m. The open house will run until 7:30 p.m. The informational open house provides the public the opportunity to meet and talk with project representatives and view detailed maps. There is no formal presentation. Visitors may come and go at any time.



The Coal Township 138 kV Transmission Line Rebuild Project involves upgrading about 4 miles of transmission line. This project is located in Liberty and Coal townships in Jackson County. The project will use several structure types, including steel H-frame and monopoles that will be about 100-feet tall. AEP Ohio anticipates completion of this project at the end of 2021. Early estimates show this is an approximate \$8 million investment.

AEP Ohio Transmission Company expects to file its application for a Certificate of Environmental Compatibility and Public Need for the Coal Township 138 kV transmission line with the state of Ohio Power Siting Board in spring 2018. This application has been assigned Case Number 18-0031-EL-BTX. This number should be included in all communications with respect to this project.

The Ohio Power Siting Board is responsible for reviewing information related to the project – including input from the public – and determining whether the proposed project should be approved. AEP Ohio is required to propose two transmission line routes to the siting board. The siting board will make the final decision on which route is selected. The accompanying concept map depicts the proposed routes the company is likely to submit to the siting board as the preferred route and alternate route. It should be noted that due to reduced scale and limited detail, this map should be used only as a general guide.

If the application is approved, construction of the transmission line could begin as early as the fall of 2020 and be completed by the end of 2021.
