Dear Ms. Turkenton and Ms. McNeal:

This letter serves as Dominion Energy Ohio's ("Applicant" or "DEO") pre-application notification letter in order for the Ohio Power Siting Board ("Board") to open a case for the proposed Chippewa Compressor Station, Chippewa Township, Wayne County, Ohio. This letter is given at least five (5) days prior to DEO's filing of a Letter of Notification.

In accordance with Ohio Administrative Code ("OAC") Rule 4906-6-03(A), DEO provides the following information for a letter of notification application:

Project Description: DEO is planning to add two 3750 hp compressor units and appurtenances to Chippewa Compressor Station. In preparation for the addition of the compressor units, DEO is planning to construct eight new pipelines and relocate three existing pipelines. All relocated pipelines will be the same diameter as the original pipe. All new and relocated pipelines and compressor units will be installed on DEO's property.

Anticipated Project Schedule: The relocation of three pipelines is anticipated to start March 2018 and completed by May 2018. The construction of the seven new pipelines is scheduled to begin July 2018 and completed by October 2019.

Expedited Treatment: DEO requests expedited treatment for this application, and will submit payment of \$2,000 in accordance with OAC Rule 4906-6-04(A)(2).
