

## Notice of First Amendment to Major Utility Facility FACILITY DESCRIPTION

The Ohio Power Siting Board ("Board") issued a Certificate of Environmental Compatibility and Public Need on October 5, 2017 in Case No. 16-2443-EL-BGN authorizing Guernsey Power Station LLC to construct, own and operate an 1,100 megawatt (MW) gas fired, combined cycle power station, Guernsey Power Station, to be located in Valley Township, Guernsey County off of Puritan Street. Seneca Lane, Interstate 77, Clay Pike Road, and a private rail line generally border the project area.

## LOCATION AND GENERAL LAYOUT

The general location and planned project layout of Guernsey Power Station is shown on the map below:



## FIRST AMENDMENT NOW PENDING

Guernsey Power Station, LLC has a First Amendment Application pending before the Ohio Power Siting Board to add an additional 550 MW of capacity for a total of 1,650 MW which was contemplated at the time of the filing of the initial Application.
