Responses to Staff Data Requests

1. What is the current MAOP of the system?

RESPONSE: 174 psi

2. Is the current section of pipe an MAOP restriction?

RESPONSE: No

3. If so, will the system be uprated with the current 8" pipe replaced?

RESPONSE: N/A

4. Can the existing pipe not be uprated to keep pace with demand?

RESPONSE: No, the existing pipe cannot be uprated because the pipe is old, but it will be upsized to 12-inch diameter due to the importance of the line supplying critical regulator stations and with most of the system being 12-inch it is good for consistency.

5. Is there leakage history, or inoperable or degrading facilities on the existing section of pipe?

RESPONSE: No.

6. At what percent capacity is the current pipe operating on peak day?

RESPONSE: *The 8-inch pipe is about 75% capacity.*

7. At what percent capacity will the proposed pipe operate on peak day?

RESPONSE: *It is expected to be about 40% capacity.*

8. How much and what kind of growth has been added downstream?

RESPONSE: There has not been significant growth.

9. Is future growth expected?

RESPONSE: No significant growth is expected in the future. The primary purpose of the replacement is to meet current demand and to permit a complete integrity evaluation along high pressure pipeline #5876 as well as to maintain pipeline safety and integrity.
