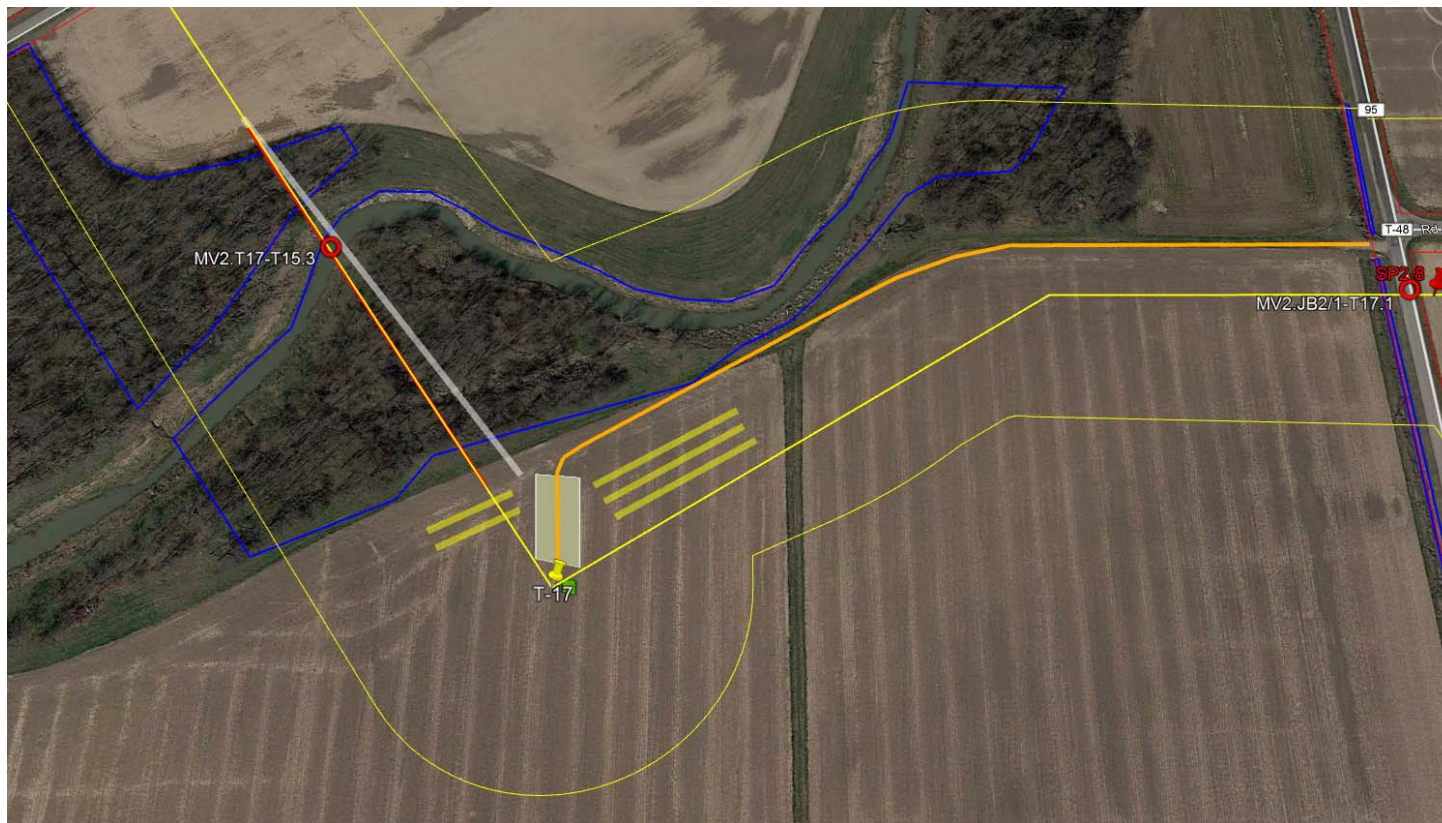

The below represents a minor change in the collection bore at WTG 17. This change stays within the study corridor approved by the OPSB, will be shown on the as-built drawings, and there are no new property owners or impacts as a result of this minor change.

On the drawing below the crane pad is represented in grey and the transformer is in green. The two yellow lines to the left of the crane pad are tower components and the three yellow lines to the right of the crane pad are the blades. The minor change is represented in white, while the original IFC path is just to the left of the white line. The crane pad, which has just now been completed in that location, will be avoided.
