This application was filed on January 25, 2018. Upon review, it has been determined that the response to Exhibit C-5 is not complete. To clarify, and relying upon the applicable filing instructions: For Case Number 18-0137-GA-AGG, provide two years of forecasted income statements for the applicant's NATURAL GAS related business activities in the state of Ohio Only, along with a list of assumptions, and the name, address, email address, and telephone number of the preparer. The forecasts should be in an annualized format for the two years succeeding the Application year. Your submission includes data for 2016, 2017 and 2018. Your C-5 Exhibit therefore shows two past years of history and one year of forecast for the application. You will need to supply your forecast for 2019, along with a list of assumptions, and the name, address, email address, and telephone number of the preparer (presumably Mr. Engle). In order to avoid suspension and/or denial of your application, please send the above referenced Exhibits to the PUCO Docketing Division with a note to include them as amendments to your applications for Case 18-0137-GA-AGG. Use separate sheets of paper for each of the required exhibits. The required amendment must be received by Docketing by Noon, February 15, 2018 and comply with filing content requirements in order for staff to have sufficient time to review the information in your application.
