

## MEMORANDUM IN SUPPORT

Trusted Energy, LLC ("Trusted Energy") hereby requests a thirty (30) day extension of its Certificate Number 14-771(E)(2), pursuant to Admin. Code 4901:1-24-09(A). Trusted Energy's certificate became effective on January 20, 2016 and expired on January 20, 2018. Trusted Energy filed its renewal application on January 16, 2018.


Rule 4901: 1-24-09 provides in pertinent part:

If the provider files such renewal application less than thirty calendar days prior to the expiration date indicated on the certificate, the provider shall file a motion to extend the expiration date on its current certificate for an additional thirty calendar days. Such motion shall be deemed automatically approved, unless otherwise ruled upon by the commission or an attorney examiner within three business days of the filing of the motion.

Under Admin. Code 4901:1-24-09, Trusted Energy's Renewal Application was due to be filed no less than thirty (30) days prior to the expiration date indicated on its provider certificate, or December 20, 2018. Trusted Energy has filed its Renewal Application less than thirty (30) days prior to the expiration date on its certificate and requests the existing certificate be extended until the renewal application, filed on January 16, 2018, is approved.

For the all of the foregoing reasons, Trusted Energy, LLC respectfully requests that its Certificate Number 14-771(E)(2) be automatically extended for thirty (30) days as permitted in Rule 4901:1-24-09(A).
