In pursuance of ~~Public~~, or public records request, I am writing you a letter concerning and describing various, in my opinion, grievances towards the Duke Energy Company, over a long period of time. My problems seem to begin with not only Duke, but also the private corporations who practice their businesses with public housing.

To keep things tidy, I will begin by saying the problems with said Energy Company began around the year 2005. The private entities doing business with the state are a sub-matter in this request.

- Grievance one; In no particular chronological order. From the years 2010 - 2017 up to December just past, I had the address of 332 North 2nd Street, in Hamilton Ohio. At this particular property which I chose to live in, which was vacant at the time, just a walk down the street from a group housing facility; I lived upstairs in Apt. B. During this I had heat for a total of 6-8 months; in seven years. Sounds strange, but I'll explain... There, I ~~had~~ had no ~~access~~ access to my billing or energy facilities. Shortly after, the apartment downstairs was inhabited by two men, I think towards that winter. I didn't say anything much to them but they had all access to the basement. Later, in November of 2016, a lady moved in and all of my problem began to spiral.

From November 2016 to December of last year, she shut off my breakers several times for being loud. ~~She~~ She had me for a guest once and I used her cell phone when I locked myself out of my apartment. We didn't get along. If this

is true, and she was recommended by the previous inhabitants, then it is safe to say that any sort of "fooling around" with the furnaces could have happened during either's tenure. But, this is irrelevant to my records, except to say they were unpleasant to live with, or above, I should say ...

Basically, I finally got the maintenance man to install a thermostat, which was the problem, according to him. The same time the lady moved into A, downstairs, in November, of 2016. After this, in November, of 2016, my bills I was finally made aware, and I mind you, I kept asking the maintenance to fix, but he would tell the landlady he did, and not, were upward of 500 dollars if so. They went up substantially for quite sometime after six years of no heat, basically. She defaulted twice saying they were too high, and blamed it on my energy usage and poor windows. She paid the bill.

— Which brings me to reference number two. I had the same problem in the other places supplemented by the state Section 8 program. Particularly in the Vienne Forest apartment complex in Middletown, Ohio and the Bavarian Woods complex where I was told by the Section 8 housing "lady" in Middletown were the only available open apartments at the time I moved in the complexes. I only want to bring this up because, I believe the Duke Energy company was, and still is "over-supplying" energy to those places during my personal tenure. So much so, that I have suffered a slew of physical and mental problems after the passing of my father in November of 2009. After my father passed on, I was admitted to the Atrium center in Middletown, Ohio, and

later then transferred to Fort Hamilton Hughes hospital in Hamilton, since Atrium doesn't have emergency physical rehabilitation centers for mental issues. Which is how I landed at 332. I the time between I was ~~prohibited~~ by the state for trying to explain "energy surges" and other mysterious "what-nots", especially a Bavarian Woods, where, for some reason, I was forced to live next to a laundry room with up to 12 meters on the outside. I believe the over-delivery of electricity to these facilities forced the doctors to "label" me outright "paranoid schizophrenic", and put under court probate in disbelief. Not only had my father gone through unnecessary stresses because of this, I'm afraid if I don't do something soon, I might lose my mother or sister.

- Side comment, once you are labeled "schizoid affective" and or "paranoid schizophrenic" by a doctor, no one will listen to you ~~or~~ believe anything you say, and everything you do is painfully scrutinized wherever you go and usually, if not always, dismissed and frowned upon. So, at the time, I was a scoundrel, even though I have never been in trouble and have maintained good standing for 'entitlements' since being labeled "bi-polar" in 1998.

- Thirdly... I was again forced to move into an all electric apartment, here in Franklin Ohio, oddly, according to my mother on the grounds that I am unstable, I suppose. But after noticing my first two months bill here at Ashgrove Apts., I basically have been delivered for January, 67 kWhs "Daily" into an apartment with a terrace I don't even use and a refrigerator and a television. I

I cannot leave the range, or any of the other breakers plugged in because these are avenues for the electricity to be delivered through, believe it or not, even when off... These readings of 1530 kWh, for 23 days in January, and Duke will say it's the electric heat, and 1316 kWh, for February, even with the breakers off, have led me to pursue some sort of "friendly" grievance with the energy company, even though they believe I'm insane. It took me two weeks for someone to finally take me seriously at Duke and they told me to go online.

- In summary, these events have led me to use the least amount of electricity after ~~they~~ checking back into Fort Hamilton Hospital in August of last year. This means I have no computer or internet access since after then and have basically been reduced to a "bunker" situation with a chair and a lamp and no metals. I don't have as many physical, and therefore "mental imbalances" now that I can possibly prove all of this.

This is why I desperately need your help in pushing something toward the possibly higher than 65.5 kWh a day that was being delivered here last months. It is now down to 35-40, but that is still too high for a refrigerator. I want to know why this is happening to me.
