MEMORANDUM IN SUPPORT

Extriciti is not a publicly traded company and, accordingly, its financial information is not publicly available. Therefore, as set forth in greater detail below, Extriciti requests that the information it designated as confidential in its Renewal Certification Application to provide retail gas broker services filed February 28, 2018, specifically Exhibits C-3 and C-5, be protected from public disclosure. The information for which protection is sought covers financial statements (C-3) and forecasted financial statements (C-5). Such information if released to the public would harm Extriciti by providing its competitors proprietary information in what is designated by statute to now be a competitive service.

Rule 4901:1-27-08 (A) states "An applicant may file financial statements, financial arrangements, and forecasted financial statements under seal. If these exhibits are filed under seal, they will be afforded protective treatment for a period of six years from the date of the certificate for which the information is being provided."

Pursuant to the above, Extriciti respectfully requests such applicable financial statements, namely Exhibits C-3 and C-5, be maintained under seal and afforded protective treatment for the promulgated six year period.
