**IGS DAYTON INC.'S APPLICATION TO ABANDON CERTIFICATE AND REQUEST
FOR WAIVERS**

Pursuant to Ohio Admin. Code 4901:1-24-12(B), IGS Dayton Inc. ("IGS Dayton") respectfully requests the Public Utilities Commission of Ohio ("PUCO") approve the abandonment of IGS Dayton's Certificate No. 00-36(E)(9) issued in Case No. 00-2171-EL-CRS on February 13, 2017. A completed *Abandonment Application for CRES Providers With No Existing Customers* ("Abandonment Form") is enclosed herewith. IGS Dayton is registered only with American Electric Power ("AEP"), Duke Energy Ohio ("Duke"), Dayton Power and Light ("DP&L"), and First Energy Company ("First Energy"). Accordingly, IGS Dayton has provided notice of its intent to abandon its certificate only to AEP, Duke, DP&L, and First Energy. See Abandonment Form, Exhibit A-2 "EDU Notice."

Because IGS Dayton has no existing customers, it respectfully requests the PUCO, pursuant to Ohio Admin. Code 4901-1-38(B), waive the 90-day filing requirements contained in Ohio Admin. Code 4901:1-24-12(B)(1) and (2) and grant this application as soon as possible.

WHEREFORE, IGS Dayton respectfully requests that the PUCO:

1. Grant IGS Dayton's request to abandon its Certificate No. 00-36(E)(9);

2. Waive the 90-day filing requirements in Ohio Admin. Code 4901:1-24-12(B)(1) and (2); and
3. Waive any requirement for IGS Dayton to continue to file quarterly reports and annual reports with respect to its CRES operations in Ohio for the 2018 reporting year and beyond.
