Dear Ms. McNeal:

Trishe Wind Ohio, LLC ("Applicant") is certified to construct a wind-powered electric generation facility in Paulding County, Ohio, in accordance with the December 16, 2013 Opinion, Order, and Certificate ("Certificate") issued by the Ohio Power Siting Board ("Board"). The Certificate is subject to the 40 conditions set forth in the December 16, 2013 Order, as well as the 26 conditions set forth in the October 1, 2013 supplement to the original application ("Supplement").

Condition 17 of the Supplement requires the Applicant to meet all recommended and prescribed Federal Aviation Administration ("FAA") and Ohio Department of Transportation Office of Aviation ("ODOT-OA") requirements to construct an object that may affect navigable airspace. This includes submitting coordinates and heights for all turbines and towers exceeding 200 feet AGL for ODOT-OA and FAA review prior to construction. At this time, Applicant is providing this letter to notify the Board that the Applicant is submitting coordinates for four additional turbines and one met tower, which are attached hereto.

In response to the application concerning the proposed construction described above, an independent study has been conducted under provisions of Ohio Revised Code Chapters 119 and 4561 to determine whether the proposed construction would be an obstruction to air navigation. The findings of that study are as follows:

The proposed construction meets notification criteria. However, we have determined that the proposed height and location will not negatively affect the safe and efficient use of the navigable airspace for any public use airport/heliport nor affect the safety of persons and property on the ground.

This permit is being approved subject to the following mandatory conditions:

[X] Notice is required if the project is abandoned or modified; maximum height 1037 feet AMSL.

[X] Obstruction Marking and/or Lighting per the current FAA Advisory Circular (AC 70/7460-1L, Change 1) "Obstruction Marking and Lighting" is required.

[X] Compliance with conditions of the FAA determination.

This authorization to initiate construction of the subject proposal expires on 8/28/2019 unless it is extended, revised or terminated by the Ohio Department of Transportation. This permit does not exempt you from coordinating with local zoning authorities regarding compliance with established zoning ordinances, nor does it exempt you from your requirement to obtain a building/construction permit from the local/state building permit authority having jurisdiction.
