Dear Ms. McNeal:

Pursuant to Rule 4906-3-03(A) of the Ohio Administrative Code, Paulding Wind Farm IV LLC (“Applicant”) files this Preapplication Notification Letter with the Ohio Power Siting Board (“Board”) regarding its proposed wind-powered electric generation facility.

The proposed facility is a wind-powered electric generation facility located in Paulding County, Ohio. The wind facility is expected to have a maximum total generating capacity of approximately 125 megawatts. The Applicant will provide clean renewable energy to electricity consumers.

The public information meeting will be held from 5:00 p.m. to 8:00 p.m. on Wednesday, April 4, 2018, at the Black Swamp Nature Center, 753 Fairground Drive, Paulding, Ohio 45879.

The Applicant anticipates filing its application with the Board within 90 days after the public information meeting. Construction of the facility is estimated to begin in the second quarter of 2019, resulting in commercial operations in the fourth quarter of 2019.
