- {¶ 1} The 131st Ohio General Assembly adopted Amended Substitute House Bill 341 (HB 341) to, in part, amend R.C. 4921.25. Newly adopted R.C. 4921.25 directed the Commission to adopt rules under R.C. Chapter 119 concerning, in part, the maximum fees that may be charged by a for-hire motor carrier engaged in towing motor vehicles or a storage facility that accepts towed vehicles.
- $\{\P\ 2\}$ A workshop was conducted on April 21, 2017, at which numerous interested parties spoke, and supplemental comments were filed by one of the parties on June 7, 2017.
- {¶ 3} Proposed rules were issued for comment in a January 3, 2018 Entry. Comments were filed by the Towing and Recovery Association of Ohio and by the Association of Professional Towers Ohio on January 18, 2018, and January 19, 2018, respectively.
- {¶ 4} In a February 28, 2018 Finding and Order, the Commission approved the proposed rules concerning maximum rates for towing and storage of motor vehicles.
- {¶ 5} In adopting these rules, R.C. 119.03 requires that a public hearing be conducted. Accordingly, a hearing shall be conducted on April 20, 2018, at 10:00 a.m., 11th Floor, at the offices of the Commission, 180 East Broad Street, Hearing Room 11-D, Columbus, Ohio, 43215.
