I. SUMMARY

{¶ 1} The Commission finds that Certificate No. 14-SPV-OH-GATS-0505 should be revoked, and this case should be dismissed and closed of record.

II. DISCUSSION

- {¶ 2} On August 29, 2014, SRECTrade on behalf of Robert Rolland (Applicant), filed an application for certification as an eligible Ohio renewable energy resource generating facility located at 3231 Burnside Road NW, Johnstown, Ohio 43041 (Facility). The Facility is named Rolland, Robert Residence R Rolland.
- {¶ 3} On October 29, 2014, the Facility was certified and Certificate No. 14-SPV-OH-GATS-0505 was issued.
- {¶ 4} On October 1, 2014, in Case No. 14-1708-EL-REN, Applicant filed a duplicate application for certification as an eligible Ohio renewable energy resource generating facility. On December 1, 2014, the facility was certified and Certificate No. 14-SPV-OH-GATS-0585 was issued.
- {¶ 5} On October 4, 2016, Applicant filed a document asking that Certificate No. 14-SPV-OH-GATS-0505 issued in this proceeding be revoked because the Facility is also certified in Case No. 14-1708-EL-REN.
- {¶ 6} On January 11, 2017, Staff filed its review and recommendation of the application. In its report, Staff states that the Facility is certified in both this case proceeding

and in Case No. 14-1708-EL-REN. Staff further states that the certificate issued in Case No. 14-1708-EL-REN has been registered with the tracking system PHM-GATS, and Solar renewable energy credits (SRECs) have been issued. Staff reports that the certification number issued in this case proceeding has not been registered with the tracking system PJM-GATS, and SRECs have not been issued.

{¶ 7} The Commission finds Staff's recommendation and the request by Applicant to revoke Certificate No. 14-SPV-OH-GATS-0505 reasonable and should be granted.

III. ORDER

- $\{\P 8\}$ It is, therefore,
- {¶ 9} ORDERED, That the request by Rolland, Robert Residence R Rolland to revoke the duplicate certification number be granted. It is, further,
