Dear Ms. McNeal:

The Commission recently concluded hosting PowerForward, which was the Commission's review of the latest in technological and regulatory innovation that could serve to enhance the consumer electricity experience. PowerForward was held in three parts: phase 1 was held April 18-20, 2017; phase 2, July 25-27, 2017; and phase 3, March 6-8 and March 20-22, 2018. Throughout PowerForward, which was widely publicized, over 125 industry experts representing diverse interests gave presentations regarding the future of the electric grid and how various technological advancements could affect different stakeholders.

In presenting PowerForward, prior to each phase the Commission published notice of the event, including an agenda outlining the topics and speakers.
