Notice of Change in Ownership Structure

Dear Secretary McNeal:

In accordance with Ohio Administrative Code 4901:1-24-11 and 4901:1-27-11, Champion Energy Services, LLC ("Champion"), Calpine Energy Solutions, LLC ("CES") and North American Power & Gas, LLC ("NAPG") hereby notify the Public Utilities Commission of Ohio ("PUCO") of a change in their corporate ownership structure.

Champion (Certificate No. 09-166E (5)), CES (Certificate No. 01-052E (9)), NAPG (Certificate No. 11-410E (4)) are Competitive Retail Electric Service Providers licensed by PUCO. NAPG is also a Certified Retail Natural Gas Provider (Certificate No. 12-249G (3)) licensed by PUCO.

CES, Champion and NAPG are wholly owned subsidiaries of Calpine Corporation ("Calpine"). On August 17, 2017, Calpine entered into an agreement and plan of merger with affiliates of ECP ControlCo, LLC ("Energy Capital Partners"), pursuant to which Energy Capital Partners acquired Calpine and thereby became an indirect owner of the various Calpine subsidiaries, including CES, Champion and NAPG. The transaction closed on March 8, 2018, after receipt of all required federal and state approvals. A chart depicting the new ownership structure of Champion, CES and NAPG is attached to this letter as Attachment A.

Although CES, Champion and NAPG are now indirectly owned by Energy Capital Partners, CES, Champion and NAPG anticipate continued operation under their current names, will be honoring their current contracts, and will continue to provide service under the same terms and conditions as currently offered to each of their customers. The acquisition of the parent company of CES, Champion and NAPG did not result in a




