EXAMINER SHEETS: The Public Utilities
Commission of Ohio has set for hearing at this time
and place, Case Nos. 17-2318-GA-RDR and
17-2319-GA-ATA.

My name is Kerry Sheets. I'm an Attorney
Examiner with the Commission. I've been assigned to
hear these cases.

May I now have the appearances of the
parties, please, starting with the Company.

MS. KINGERY: Thank you, your Honor. On
behalf of Duke Energy Ohio, 139 East Fourth Street,
Cincinnati, Ohio, my name is Jeanne Kingery. I'd
also make the appearance of Rocco D'Ascenzo. Thank
you.

EXAMINER SHEETS: From OCC.

MR. WOLTZ: Thank you, your Honor. On
behalf of the residential consumers of Duke Energy
Ohio, Office of the Consumers' Counsel, Bruce Weston,
Ohio Consumers' Counsel, by Zachary Woltz, 65 East
State Street, 7th floor, Columbus, Ohio 43215.

EXAMINER SHEETS: And now Staff.

MR. BEELER: Thank you, your Honor. On

1 behalf of the Staff of the Public Utilities
2 Commission of Ohio, Ohio Attorney General Mike
3 DeWine's office, I'm Steve Beeler, Assistant Attorney
4 General, and I'm at 30 East Broad Street, 16th floor,
5 Columbus, Ohio 43215.

6 EXAMINER SHEETS: Thank.

7 Now, do you have a statement to make?

8 MS. KINGERY: Thank you, your Honor.

9 The parties have discussed ahead of time
10 how we would handle the testimony in this proceeding.
11 There is a Stipulation that we will put into the
12 record between the Company and Staff of the
13 Commission. There are also witnesses supporting both
14 the Application and the Comments in favor of and
15 against the Stipulation, so we will put all of those
16 into the record, and then all parties have agreed to
17 waive cross-examination.

18 EXAMINER SHEETS: Okay. Good. Now, do
19 we have exhibits to mark?

20 MS. KINGERY: I apologize?

21 EXAMINER SHEETS: Exhibits to mark.

22 MS. KINGERY: Yes. Thank you, your
23 Honor.

24 As Duke Energy 1, I would ask that we
25 label the Pre-Filing Notice that was filed in this

1 docket on November 28th, 2017.

2 As Duke Energy Exhibit 2, we would mark
3 the Application of Duke Energy Ohio filed on
4 February 26th, 2018.

5 Duke Energy Ohio Exhibit 3 would be the
6 Direct Testimony of Sarah E. Lawler also filed on
7 February 26th, 2018.

8 Duke Energy Exhibit 4 would be the
9 Supplemental Testimony of Sarah E. Lawler filed on
10 April 5th, 2018.

11 And then I would propose Joint Exhibit 1
12 for the Stipulation and Recommendation between Staff
13 and the Company which was filed in the docket on
14 April 5, 2018.

15 (EXHIBITS MARKED FOR IDENTIFICATION.)

16 EXAMINER SHEETS: Okay. Good.

17 MS. KINGERY: And I would move for
18 admission of those documents into the record.

19 EXAMINER SHEETS: OCC, do you have
20 exhibits?

21 MR. WOLTZ: Yes, your Honor.

22 We would like to have marked as OCC
23 Exhibit 1, the Direct Testimony of Daniel J. Duann
24 filed on April 5th of 2018.

25 We would also like to move into the

1 record the Direct Testimony and have marked as
2 Exhibit 2 of James D. Williams filed on April 5th,
3 2018.

4 And then we would also have marked OCC
5 Exhibit 3, the Supplemental Testimony of James D.
6 Williams filed in this proceeding on April 10th,
7 2018.

8 (EXHIBITS MARKED FOR IDENTIFICATION.)

9 EXAMINER SHEETS: Okay. Good.

10 Does Staff have any exhibits?

11 MR. BEELER: Your Honor, Staff would move
12 for the admission of what has been marked as Staff
13 Exhibit 1 which are the Comments and Recommendations
14 submitted on behalf of the Staff of the Public
15 Utilities Commission and those were submitted on
16 March 28th, 2018.

17 (EXHIBIT MARKED FOR IDENTIFICATION.)

18 EXAMINER SHEETS: Very good.

19 I will admit all of those exhibits into
20 evidence at this time.

21 (EXHIBITS ADMITTED INTO EVIDENCE.)

22 EXAMINER SHEETS: Is there anything else
23 we need to bring up?

24 MR. WOLTZ: A question, your Honor.
25 Would you like OCC to move their Comments into the

1 record as well?

2 EXAMINER SHEETS: I'm sorry, what?

3 MR. WOLTZ: Would you like for OCC to
4 request that their Comments be marked as an exhibit
5 and moved into the record as well that were filed in
6 this case?

7 EXAMINER SHEETS: You can do that, yeah.

8 MR. WOLTZ: So OCC would request its
9 Comments, filed on March 30th, 2018, marked as
10 Exhibit 4, OCC Exhibit 4.

11 (EXHIBIT MARKED FOR IDENTIFICATION.)

12 (EXHIBIT ADMITTED INTO EVIDENCE.)

13 EXAMINER SHEETS: Okay. Let's -- is
14 there anything more?

15 MS. KINGERY: You had a witness.

16 MR. WOLTZ: OCC has one witness, your
17 Honor.

18 EXAMINER SHEETS: I want to get to the
19 briefing schedule now. We've decided on Monday the
20 16th for briefs?

21 MS. KINGERY: That's correct. And only
22 one round is my understanding.

23 EXAMINER SHEETS: Okay. And the
24 Commission will then make its decision on what's been
25 submitted here today. Thank you.

1 MR. BEELER: OCC is going to put on --

2 MR. WOLTZ: OCC had one correction to
3 make in its Exhibit 2, your Honor. If we may put
4 that witness on to make that one correction?

5 MS. KINGERY: Duke would not object.

6 EXAMINER SHEETS: Okay.

7 MR. BEELER: Staff doesn't object either.

8 MR. WOLTZ: So then, your Honor, we'd
9 call James D. Williams to the stand.

10 EXAMINER SHEETS: Let's go off the record
11 here just a minute.

12 (Discussion off the record.)

13 EXAMINER SHEETS: Let's go back on the
14 record.

15 (Witness sworn.)

17 JAMES D. WILLIAMS

18 being first duly sworn, as prescribed by law, was
19 examined and testified as follows:

20 DIRECT EXAMINATION

21 By Mr. Woltz:

22 Q. Mr. Williams, can you state your name and
23 business address, please.

24 A. Yes. My name is James D. Williams. My
25 business address is 65 East State Street, 7th floor,

1 Columbus, 43215.

2 Q. By whom are you employed and what is your
3 position?

4 A. The Office of the Ohio Consumers'
5 Counsel, and I'm a Utility Consumer Policy Analyst.

6 Q. Do you have before you what has
7 previously been marked as OCC Exhibit 2?

8 A. Yes, I do.

9 Q. Can you identify that document?

10 A. This is my Direct Testimony filed on
11 April 5th, 2018.

12 Q. Was that testimony prepared by you or at
13 your discretion?

14 A. Yes, it was.

15 Q. Do you have any corrections to make to
16 OCC Exhibit 2 at this time?

17 A. I have one minor correction to make. On
18 page 4 of the testimony on line 2, changing the word
19 "riser" -- "rider" to "riser." So that sentence
20 beginning on line 1 should read "the use of the AMRP
21 Rider to collect costs from customers associated with
22 the riser replacement program...."

23 Q. And do you have any other corrections to
24 make at this time?

25 A. That's the only correction I have.

1 Q. And if I were to ask you the same
2 questions as are in your Exhibit 2 at this time,
3 would your answers be the same?

4 A. Yes, they would be.

5 MR. WOLTZ: Thank you.

6 Your Honor, I move admission of OCC
7 Exhibit 2 pending any further issues.

8 MS. KINGERY: No objections, your Honor.

9 MR. BEELER: No objections.

10 EXAMINER SHEETS: Okay.

11 MR. WOLTZ: Thank you, your Honor.

12 MS. KINGERY: The Company has nothing
13 else, your Honor.

14 EXAMINER SHEETS: Okay. I thank you all
15 for coming.

16 MS. KINGERY: Thank you.
