To Whom it May Concern:

In accordance with OH ADC 4901:1-24 and OH ADC 4901:1-27, HIKO Energy, LLC (the “Company”), a New York limited liability company and duly licensed Competitive Retail Electric Supplier & Competitive Retail Natural Gas Supplier in the State of Ohio, the Company hereby respectfully submits its license update:

On March 1, 2018, Spark HoldCo, LLC, parent company of Spark Energy, LLC and Spark Energy Gas, LLC, as well as an affiliate of Spark Energy, Inc. (NASDAQ: SPKE) (“Spark”), acquired 100% of the membership interests of the Company, thereby implementing a change of control of the ownership of the Company. Pursuant to the transaction, neither the Company nor Spark intend to make any changes in the Company’s services or customer population for the foreseeable future, other than changes made in the ordinary course of business. Little has changed in the ongoing business of HIKO and the sale should not affect our customers.

The name, FEIN, and DUNS number of the Company shall all remain the same. The Company shall continue to serve its existing customers and maintain key operating personnel. Please find the Company’s Officers’ List attached hereto as Attachment A and made a part hereof.
