I. SUMMARY

{¶ 1} The Commission finds that Certificate No. 16-SPV-OH-GATS-0053 should be rescinded and this case be dismissed and closed of record.

II. DISCUSSION

- {¶ 2} On December 9, 2015, John Eichelberger (Applicant) filed an application for certification for Eichelberger, John Residence ~ J Eichelberger, 4343 Selma Road, Springfield, OH, as an eligible Ohio renewable energy resource generating facility.
- {¶ 3} Ohio Adm.Code 4901:1-40-04(F)(2), provides for automatic approval of an application for certification as an eligible Ohio renewable energy resource generating facility, unless the Commission suspends the application within sixty days. The facility was automatically approved, and a certificate was issued, on February 8, 2016.
- {¶ 4} On March 3, 2016, Applicant contacted Staff to inform them that the application filed in this proceeding should not have been filed as a certificate for this facility has already been issued in Case No. 14-2210-EL-REN. As such, Applicant requests that the Commission withdraw the duplicate application and rescind Certificate No. 16-SPV-OH-GATS-0053.
- {¶ 5} On June 20, 2016, Staff filed its Review and Recommendation, requesting that the Commission rescind the duplicate certificate issued in this proceeding. Staff further

notes that the certificate issued in Case No. 14-2210-EL-REN is currently registered with the Generation Attribute Tracking System and, thus, should be the certificate retained by the Commission.

{¶6} The Commission agrees with Staff's recommendation and finds that Applicant's request to withdraw the duplicate application is reasonable and should be granted. Accordingly, Certificate No. 16-SPV-OH-GATS-0053 should be rescinded and this case be dismissed and closed of record.

III. ORDER

- {¶ 8} ORDERED, That Applicant's request to withdraw the duplicate application and rescind Certificate No. 16-SPV-OH-GATS-0053 be granted. It is, further,
- {¶9} ORDERED, That Case No. 15-1963-EL-REN be dismissed and closed of record. It is, further,
