## APPLICATION OF VOLUNTEER ENERGY SERVICES, INC. TO AMEND ITS ANNUAL REPORT FOR CALENDAR YEAR 2016

Volunteer Energy Services, Inc. ("VESI") is authorized to provide electric aggregation and power broker services in this state pursuant to Certificate No. 15-950-E(2), which was issued by the Commission on March 22, 2017 in Case No. 15-0375-EL-CRS.

Pursuant to the Commission's February 1, 2017 entry in this docket, VESI filed its annual report for calendar year 2016 on March 20, 2017. However, as the result of a recent internal review, VESI has determined that it understated the brokerage fees and commissions realized during 2016 in reporting its revenue. Accordingly, by this application, VESI requests leave to amend its 2016 annual report to show the correct amount of brokerage fees and commissions. VESI recognizes that the change in the reported 2016 revenue will affect the amount of the PUCO maintenance assessment due November 2018. Unless instructed otherwise by the Commission staff, VESI will pay its estimate of the adjusted amount of the PUCO assessment on or before the due date.

WHEREFORE, VESI respectfully requests that its application to amend its 2016 annual report be granted and that the amended annual report attached hereto be accepted for filing.
