I am a father of five children, one of whom was born with a diagnosis of Congenital Mesoblastic Nephroma, which is a very rare kidney cancer. She was given 1 year to live and by the grace of God is now 15 and cancer free. However she does have many disabilities mentally and physically with one disability being a sensory deficit to visual effects and certain sound types. Being able to raise her in a quiet rural atmosphere has helped her grow stronger by being able to enjoy her life outside without all the visual and sound distractions that a city life entails.

I built our family home with my own two hands from the ground up. Our home is located in beautiful rural Seneca County. I raise all of my children to respect the land, the farmers who take care of it, habitat and everyone they come into contact with.

However, I am raising them to not be walked on, pushed around or bullied by those in higher power in relation to monetary greed. I strongly believe that the outcome of this situation will have a serious impact on the next generation and how they treat/respect one another and our precious land.

People complain that children have no respect and live on electronics. Also claiming that obesity is at an all time high along with serious health complications that come along with being obese. If the rural area is over taken with industrial turbines, the children who once enjoyed viewing and listening to the habitat, admiring and respecting the land, striving to keep the earth clean by taking part in recycling projects and staying physically fit by being outside walking the country block, riding bikes, and just simply listening to the beautiful mesmerizing sound of Mother Nature will fade away. They will turn into people who respect nothing as their values, properties, rights, and dreams were selfishly not respected and taken away.

In our Seneca County area, which is very densely populated with families and children, they are trying to surround non-participating residential homes with these turbines. This is greatly disturbing many residents to the point of considering relocating their families and/or ready to become financially burdened by obtaining strong legal representation. We are requesting your assistance in any way to prevent Republic Wind Farm (Docket# 17-2295-EL-BGN) and the Seneca Wind LLC (Docket#18-0488-EL-BGN) from building in Sandusky and Seneca County and destroying the preciousness of rural living, scenery and habitat.

Other states are now acknowledging the negative impacts of wind farms with declining property values, increased utility bills due to having to pay for these turbine projects with tax dollars. They are also acknowledging the negative effects it has on all aspects of human life including the physical and mental effects that are causing lasting harm.

Every year we spray chemicals to destroy mosquitoes that can spread deadly disease. Imagine the quantity of toxic chemical that will need to be sprayed in the air if our natural defender, our first line of defense, the bat is further strained as it is already on a dangerous decline. Imagine along with this the increase in diseases spread nationwide do to the decline of the bat population. This is something that can be prevented by making the right decision.

To my knowledge the Wind Industry is fighting hard in Ohio to allow these turbines to be placed even closer to homes where their ice can be thrown and cause physical damage/harm. Their noise and flickering shadow having the ability to disrupt families while in their homes and in some cases having the ability to lead to sever mental illnesses such as depression due to feeling like being trapped with no where to go.

I also feel it needs to be known that there have been health departments in other states declaring wind farms human health hazards. One health department with strong documentation is that of Brown County, Wisconsin. Superintendents writing letters warning of the negative impacts on children and families after the wind farm projects are up and running, such as the letter from Superintendent William C. Mulvaney of Armstrong Schools which can be located through contacting them. Then there are doctors such as, Sandy Reider, MD (graduate of the Harvard University School of Medicine) who has testified before the Vermont Public Service Board, Senate National Resource and Health Care Committees, as well as the Governor's Siting Commission on the negative effects on human health and the severe negative impact especially on the more vulnerable, children and the elderly.
