Dear Resident or Property Owner:

You're receiving this letter because our records indicate that you live near an upcoming transmission line project. In accordance with Rules 4906 of the Ohio Administrative Code (OAC), AEP Ohio Transmission Company, Inc., (AEP Ohio Transco) is required to submit a Letter of Notification to the State of Ohio Power Siting Board (OPSB) whenever certain changes are made to our transmission facilities.

AEP Ohio announced this project as the North Jackson 138 kV Transmission Line Project in July as part of the overall Jackson-Ross County Area Improvements. The company is filing this project with the OPSB as the Heppner Switch-Lick 138 kV Transmission Line Project, Public Utilities Commission of Ohio Case Number 17-0808-EL-BLN.

The project consists of upgrading about 4 miles of 69-kilovolt (kV) transmission line to 138 kV. About 3 miles of the line will be rebuilt within the existing right-of-way. The remaining mile of the line will require construction in new areas and new easements. The line travels through Coal and Lick townships and the city of Jackson in Jackson County. AEP Ohio Transco will upgrade the line by using several structure types including steel single pole and H-frame structures. Rebuilding the line will improve the electric transmission reliability and allow for economic development in the area. This project will be an approximate \$10 million investment by AEP Ohio Transco. Construction is scheduled to begin in early 2019.

In compliance with Rule 4906-6-01, et seq., of the OAC, we have prepared and filed a Letter of Notification with the OPSB. The Letter of Notification to construct, operate and maintain this facility is pending before the board.

You can also send your comments directly to the OPSB at its contact information listed below. Petitions to intervene in the OPSB process can be filed to the siting board up to 10 days following the public notice announcing the project.

AEP Ohio Open House to Discuss Electric Transmission Line

AEP Ohio Transmission Company Inc., (AEP Ohio Transco), an affiliate of AEP Ohio, plans to upgrade a 69-kilovolt (kV) transmission line to 138 kV in Coal and Lick townships and the city of Jackson in Jackson County. The project is known as the Heppner Switch-Lick 138 kV Transmission Line Project. This project is part of the Jackson-Ross County Area Improvements. This project was previously announced as the North Jackson 138 kV Transmission Line Project in July of 2017.

The purpose of the project is to improve the electric transmission infrastructure in southern Ohio and allow for economic development. The North Jackson transmission line is about 4 miles long. About 3 miles of the line will be rebuilt within the existing right-of-way. The remaining mile of line will require construction in new areas and new easements. AEP Ohio Transco will upgrade the line by using several structure types including steel single pole and H-frame structures. This project will be an approximate \$10 million investment by AEP Ohio Transco. Construction is scheduled to begin in early 2019.

AEP Ohio Transco filed a Letter of Notification with the Ohio Power Siting Board (OPSB) as the Heppner Switch-Lick 138 kV Transmission Line Project, Case No. 17-0808-EL-BLN. This number should be included in all communications related to this project. The Letter of Notification to construct, operate and maintain this facility is pending before the OPSB.

Petitions to intervene in the Letter of Notification will be accepted by the OPSB up to 10 days following the publication date of this notice required by Rule 4906-2-12, Ohio Administrative Code. Petitions should be addressed to Ohio Power Siting Board, 180 East Broad Street, Columbus, Ohio, 43215-3793 and must cite Case No. 17-0808-EL-BLN.

The accompanying map depicts the project area. It should be noted that due to the reduced scale and limited detail, this map should be used only as a general guide. 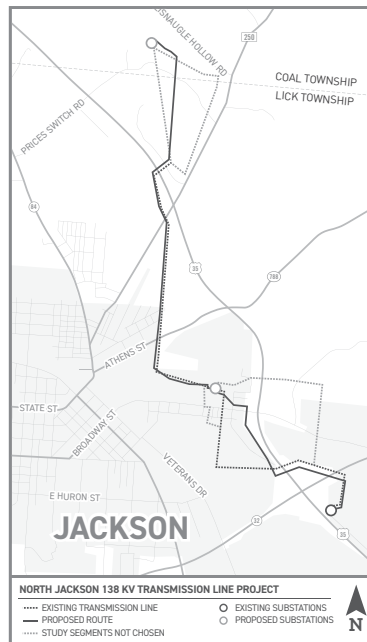
