JOINT MOTION FOR INDEFINITE STAY OF PROCEEDINGS

In accordance with Ohio Adm. Code 4901-1-12, The East Ohio Gas Company d/b/a Dominion Energy Ohio (DEO) and Nathan and Chany Klein (Complainants) respectfully request that the Commission indefinitely stay these proceedings. Good cause exists to grant this request for the following reasons.

Following a lengthy period of discussions and negotiations, the parties have reached an agreement in principle to settle this matter and have executed a confidential agreement to that end. Given the time required for performance under the agreement, however, the matter has not yet been conclusively resolved, so it would not yet be appropriate to dismiss the complaint with prejudice. Therefore, the parties jointly request that the Commission stay these proceedings or otherwise hold them in abeyance. If performance is completed, the parties will file a joint motion to dismiss the complaint with prejudice. If performance is not completed, either party or both parties will notify the Commission or the presiding examiner and may take such other action as may be proper at that time, including filing a request to lift the stay. At all events, the parties will provide the presiding examiner with updates as requested.

For the reasons set forth above, the parties request that the Commission indefinitely stay these proceedings.
