- {¶ 1} The Dayton Power and Light Company (DP&L) is an electric light company and a public utility as defined by R.C. 4905.03(C) and R.C. 4905.02, respectively. As such, DP&L is subject to the Commission's jurisdiction pursuant to R.C. 4905.04, 4905.05, and 4905.06.
- {¶ 2} On November 30, 2015, DP&L filed applications for an increase in electric distribution rates, for accounting authority, and for approval of revised tariffs.
- {¶ 3} On March 12, 2018, Staff filed a written report of its investigation (Staff Report).
- {¶ 4} By Entry issued March 14, 2018, the attorney examiner issued a procedural schedule for these proceedings. In part, the schedule established a prehearing conference date of May 3, 2018, and a hearing date of May 14, 2018. The prehearing conference was conducted as scheduled. At that time, Staff was directed to submit its prefiled testimony by May 10, 2018.

{¶ 5} On May 3, 2018, Staff filed a motion for continuance of the May 14, 2018 hearing. On May 7, 2018, the attorney examiner granted the Staff's motion and directed that Staff's testimony be filed on June 1, 2018. Pursuant to the examiner's ruling, the hearing commenced May 14, 2018, and was continued until June 6, 2018.

- {¶ 6} On May 31, 2018, DP&L filed a motion for a continuance of the hearing date and Staff's deadline for filing testimony in order to allow further settlement discussions. On June 1, 2018, the attorney examiner granted DP&L's motion, directed Staff to file its testimony by June 8, 2018, and continued the hearing to June 13, 2018. The attorney examiner additionally scheduled a prehearing conference for June 6, 2018.
- {¶ 7} At the prehearing conference conducted June 6, 2018, Staff requested that it not be required to file testimony until June 12, 2018. The other parties had no objection to the request on the condition that Staff not present witnesses at the hearing until June 20, 2018, in order to provide time to review the testimony. The attorney examiners granted Staff's request and directed Staff to file testimony by June 12, 2018.
- {¶ 8} Subsequently, on June 11, 2018, a conference call was conducted in order to advise the attorney examiners of the status of settlement discussions and to discuss the procedural schedule. Based on Staff's representations, and with no objections or comments made by DP&L or the intervening parties, the attorney examiners suspended the procedural schedule.
 - $\{\P 9\}$ On June 18, 2018, a stipulation was filed.
- {¶ 10} The attorney examiner finds that a prehearing conference should take place on June 20, 2018, at 10:00 a.m. at the offices of the Commission, 180 East Broad Street, Hearing Room 11-A, Columbus, Ohio. At the prehearing conference, the parties should be prepared to discuss procedural matters and schedule a new hearing date.

 \P 12} ORDERED, That a prehearing conference be scheduled for June 20, 2018, in accordance with Paragraph 10. It is, further,
