- {¶ 1} The Dayton Power and Light Company (DP&L) is an electric light company and a public utility as defined by R.C. 4905.03(C) and R.C. 4905.02, respectively. As such, DP&L is subject to the Commission's jurisdiction pursuant to R.C. 4905.04, 4905.05, and 4905.06.
- **{¶ 2}** On November 30, 2015, DP&L filed applications for an increase in electric distribution rates, for accounting authority, and for approval of revised tariffs.
- {¶ 3} On March 12, 2018, Staff filed a written report of its investigation (Staff Report).
- {¶ 4} By Entry issued March 14, 2018, the attorney examiner issued a procedural schedule for these proceedings. In part, the schedule established a prehearing conference date of May 3, 2018, and a hearing date of May 14, 2018. The prehearing conference was conducted as scheduled.
- {¶ 5} By Entries dated May 7, 2018, and June 1, 2018, the attorney examiners granted motions to continue the hearing and filing of Staff's testimony submitted by Staff

and DP&L, respectively. By those Entries, the attorney examiners scheduled an additional prehearing conference on June 6, 2018, and a hearing on June 13, 2018. At the June 6, 2018 prehearing conference, the attorney examiners granted a request by Staff that the deadline for filing Staff testimony be extended to June 12, 2018.

- $\{\P 6\}$ Subsequently, at the conclusion of a June 11, 2018 conference call, the attorney examiners suspended the procedural schedule in anticipation of an expected stipulation.
- {¶ 7} On June 18, 2018, DP&L filed a stipulation (Stipulation) representing an agreement amongst most, but not all, of the parties.
- {¶ 8} By Entry dated June 19, 2018, the attorney examiners scheduled a prehearing conference for June 20, 2018. As discussed with the parties at the prehearing conference, the attorney examiners hereby establish the following procedural schedule:
 - (a) Testimony. DP&L shall file testimony in support of the Stipulation on or before June 26, 2018. Testimony filed by intervening parties in support of the Stipulation shall be filed by July 2, 2018. Staff testimony and any testimony filed by parties opposing the Stipulation shall be filed by July 16, 2018.
 - (b) Discovery. The discovery deadline shall be July 18, 2018. The scope of discovery is limited to the Commission's three-prong test for reviewing the reasonableness of a stipulation, to any findings and recommendations in the Staff Report that are modified by the Stipulation, and to findings and recommendations in the Stipulation that were not included in the Staff Report. The parties shall respond to discovery requests within five business days.
