We would like to file a complaint and offer related comments regarding the proposed Seneca Wind Farm.

As an adjacent landowner, a company named Atwell has issued a so called Good Neighbor contract to us that is entitled "Wind Farm Neighbor Easement And Setback Waiver Agreement". There are several aspects of this agreement that we take serious exception to.

First, if we sign the contract, we waive our right to file a claim for damages related to the "Effects" as defined in the contract as" "audio, visual, view, light, shadow flicker, vibration, air turbulence, wake, electromagnetic, ice, or other weather created hazards or other effects of any kind whatsoever resulting directly or indirectly from the operation of the Wind Farm...". This sure seems to us as an admittance that the negative side effects of wind turbines do actually exist.

Secondly, if we sign the contract, we agree to a "Setback Easement" which in our interpretation means that the turbine can be located anywhere on the adjacent landowner's property even closer than what the current State law defines.

Thirdly, the contract includes a Confidentiality clause where if we sign we cannot disclose the terms of the agreement to anyone else. What are they trying to hide?

For all of this, we get a whopping \$500 signing bonus and \$500 per year payment. Wow!

I find all of this to be quite disturbing and unacceptable. I ask for the help of my State government to protect the rights of all property owners.

I have attached an edited version of the contract as a reference where only the confidential information has been removed such as names, addresses, deed, etc.
