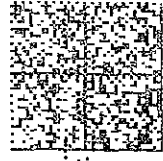

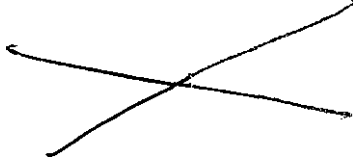

**Re: Five days left to file your 2017 Annual report - \$1,000 forfeiture will assessed after Friday, July 6, 2018 for non-compliance.**

Dear All Things Energy LLC,

This is a notice from Public Utilities Commission of Ohio that our records indicate that Certificate #13-654E has not filed a 2017 Annual Report. **You have five days left until a \$1,000 forfeiture will be assessed for non-compliance!** The Commission has ordered you to file your annual report by July 6, 2018 and directed a \$1,000 civil forfeiture against those companies who fail to file, pursuant R.C. 4905.54. (Case No. 18-01-AU-RPT, finding and order June 6, 2018).

Companies must register to gain access to the PUCO Community and file the 2017 annual report. Please call (614) 466-6904 to register.

**File your annual report:** Please immediately log in into our new online filing system in the PUCO Community at <https://community.puco.ohio.gov/>, and click on Mandatory Reports to start your annual report filing.

**Received in error or you already filed an annual report?** If you have submitted a report and received an email confirmation, please verify that your report has been posted on our website.

**If you do not believe your company is required to file an annual report this year:** Each regulated entity will be required to file a 2017 annual report for each certificate or operating authority held that was effective at any time during the 2017 calendar year, even if the entity did not conduct operations in Ohio.
