# RETAIL ENERGY SUPPLY ASSOCIATION'S MOTION FOR A SUBPOENA DUCES TECUM DIRECTED TO THE DAYTON POWER AND LIGHT COMPANY

Under Ohio Administrative Code § 4901-1-25, the Retail Energy Supply Association ("RESA") respectfully moves the Public Utilities Commission of Ohio (the "Commission"), any commissioner, the legal director, the deputy legal director, or any attorney examiner to issue a subpoena duces tecum ("Subpoena") directed to Dayton Power and Light Company ("DP&L") that compels DP&L to produce a person(s) to attend and give testimony at the Public Utilities Commission of Ohio in Case No. 15-1830-EL-AIR, *et al.* on July 24, 2018 or another mutually agreed time.

### MEMORANDUM IN SUPPORT OF RETAIL ENERGY SUPPLY ASSOCIATION'S MOTION FOR A SUBPOENA DUCES TECUM DIRECTED TO THE DAYTON POWER AND LIGHT COMPANY

In this proceeding, DP&L filed an application requesting authority to increase its distribution rates. As part of its application, DP&L filed the testimony of several witnesses to support the application and schedules. The Staff Report of Investigation issued by the Staff relies upon this information, as well as discovery responses sponsored by DP&L witnesses.

On June 18, 2018, DP&L and other parties submitted a Stipulation and Recommendation attempting to resolve certain issues in the proceeding. On July 11, 2018, DP&L and the City of Dayton submitted a supplemental stipulation seeking to resolve additional issues.

In support of the Stipulation, DP&L intends to call one witness: Sharon Schroder.

Ms. Schroder, however, simply speaks to whether the stipulation satisfies the threeprong test. Because Ms. Schroder has not been offered to support any portion of the

application, testimony, or discovery responses relied upon by the Staff Report or the Staff, Ms. Schroder's testimony alone will not allow for sufficient development of the record.

Thus, the Commission should require DP&L to present the requested witnesses at trial as described in the executed Subpoena attached to RESA's motion. RESA respectfully asks that the Commission grant this motion.
