## Notice of Proposed Solar-Powered Utility Facility

Vinton Solar Energy LLC ("Vinton"), a wholly-owned subsidiary of Invenergy Solar Development North America LLC, is proposing to construct a solar-powered generation facility located in Vinton County, Ohio. The proposed project is a solar field producing up to 125 megawatts of electricity, located in Vinton County, Ohio, in the township of Elk. The Vinton Solar Energy Project will produce clean, renewable, reliablypriced, low-cost electricity to the Ohio bulk power transmission grid.

The following map shows the proposed layout of the Vinton Solar facility.



Vinton Solar Energy, LLC filed an application with the Ohio Power Siting Board (OPSB) for a certificate to construct, operate, and maintain the proposed facility in OPSB Case No. 17-774-EL-BGN; the application is currently pending before the OPSB.

A local public hearing where the OPSB will accept written or oral testimony from any person will commence at 6:00 p.m., on July 24, 2018, at the Vinton County Community Building, 31935 State Route 93, McArthur, OH 45651. Subsequently, an adjudicatory hearing will commence on August 1, 2018, at 10:00 a.m., 11th floor, Hearing Room 11-D, at the offices of the Public Utilities Commission of Ohio, 180 E. Broad St., Columbus, OH 43215. The initial notice regarding the proposed facility and hearings was published in The Vinton County Courier on June 27, 2018.
