MEMORANDUM IN SUPPORT

On February 1, 2017, as supplemented, Icebreaker filed an application for a certificate of environmental compatibility and public need for the Icebreaker Project to be located in Lake Erie eight miles off the shore of Cleveland, Ohio in Cuyahoga County ("Application").

On April 20, 2018, the ALJ issued the procedural schedule in this case, which, among other things:

- 1. Scheduled the evidentiary hearing for August 6, 2018.
- 2. Established July 23, 2018, as the due date for the filing of expert and factual testimony to be offered by the Applicant.
- 3. Established July 27, 2018, as the due date for the filing of expert and factual testimony to be offered by intervenors and Staff.

Icebreaker believes that settlement discussions could likely lead to a full stipulation resolving all issues in this matter. While Icebreaker has been preparing a proposed stipulation, the Applicant held off on presenting the proposal to the parties until after the second local public hearing was held on July 19, 2018, so that the stipulation could reflect any relevant comments presented at the local hearing and allow the parties to take any comments made at the hearing into consideration during their settlement deliberations.

In light of the fact that Icebreaker's testimony supporting the Application is due Monday, July 23, 2018, and the parties have not yet had sufficient time to review the proposed stipulation and commence settlement discussions, the Applicant is filing this request for an extension of time of the procedural schedule. Specifically, the Applicant requests that the Board or ALJ schedule a prehearing conference for July 30, 2018, at which time the new filing dates for testimony and

commencement of the hearing can be discussed and determined, with the goal being that the evidentiary hearing will commence as soon as possible.

Given the short time frame before testimony is currently due, Icebreaker requests that this motion be granted on an expedited basis for good cause shown.
