Entered in the Journal on July 25, 2018

- {¶ 1} Pursuant to R.C. 4905.26, the Commission has authority to consider written complaints filed against a public utility or an electric services company by any person or corporation regarding any rate, service, regulation, or practice relating to any service furnished by the public utility that is in any respect unjust, unreasonable, insufficient, or unjustly discriminatory.
- $\{\P\ 2\}$  Ohio Power Company dba AEP Ohio (AEP) is a public utility as defined in R.C. 4905.02 and, as such, is subject to the jurisdiction of this Commission.
- {¶ 3} On April 18, 2018, Harry Reeves (Complainant) filed a complaint against AEP, alleging excessively high bills for February 2018 through March 2018. Complainant asserts that electricians have checked his major appliances, but were unable to find any cause for the high bills.
- {¶ 4} On May 7, 2018, AEP filed its answer and a motion to dismiss. AEP admits that Complainant's meter was checked and found to be operating at 99.82 percent accuracy on a full load and 99.78 percent accuracy on a light load. AEP denies the allegations made by Complainant.
