



## MARKET SERVICE ORDER #9

This MARKET SERVICE ORDER (MSO #9), including all Exhibits attached hereto, which are incorporated herein by reference (collectively referred to as the "MSO"), is effective as of April 6<sup>th</sup>, 2018 (the "Effective Date"). This MSO is being executed and delivered by the parties pursuant to that certain Backhaul Services Addendum ("BSA") to the Master Services Agreement dated January 14<sup>th</sup>, 2015 (the "Agreement") between Agile Network Builders, LLC ("Agile"), and T-Mobile USA, Inc., a Delaware corporation ("T-Mobile").

All terms and conditions set forth in Agreement (including the BSA and other addenda and exhibits) shall have full force and effect unless specifically superseded by this MSO. Capitalized terms used herein shall, unless a specific meaning is stated herein, have the respective meanings ascribed to them in the BSA and Agreement. References to the Agreement include all of its addenda and exhibits, except as otherwise expressly stated.

## RECITALS:

WHEREAS, T-Mobile and Agile are parties to the Agreement to which the BSA is an addendum;

WHEREAS, this MSO is a Service Order for T-Mobile ordering Services (as defined in the BSA) and Agile to provide such Services in conformance with the Technical Specifications to Points of Termination at the Sites listed in <u>Exhibit C</u> and T-Mobile's switch(es) serving those Sites; and

**NOW**, **THEREFORE**, in consideration of the foregoing and the mutual promises and covenants contained herein, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties hereby mutually agree as follows:

## A. Service Type and Term

- 1. The recitals are incorporated into this MSO.
- 2. Subject to the terms and conditions of the Agreement (including the BSA) and this MSO, T-Mobile orders and Agile commits to delivering Services (as defined in the BSA) to the nineteen (19) Sites described in <u>Exhibit C</u> attached hereto and in accordance with the Agreement, the BSA and this MSO along the minimum time frames set forth in <u>Exhibit B</u> but no longer than six (6) months, not to exceed 180 days from execution of this MSO ("Deployment Commitment"). All Services are end-to-end with demarcation points at MSO Sites to T-Mobile's MSC. The parties acknowledge and agree that this MSO applies solely to the MSO Sites and not any other Sites that are subject to the Agreement or the BSA.
- 3. Service capacities and their associated Monthly Recurring Charges (the "MRC") and Non-Recurring Charges (the "NRC") for the Services are set forth in <u>Exhibit A</u>.

4. The Service Term for all MSO Sites of this MSO will be seven (7) years, commencing on the Service Commencement Date. T-Mobile may increase or decrease (after an initial increase) the capacity for Service at an MSO Site within the ranges set forth on <u>Exhibit A</u> and such changes will not incur any termination liability or modify any term, including, without limitation, the Service Term; except the applicable MRC will change based on the capacity in accordance with <u>Exhibit A</u>.

#### B. Technical

- Agile will deliver the Services for all MSO Sites to one (1) MSC location, which may be expanded by agreement of the parties to a maximum of two (2) MSC locations, provided T-Mobile will pay Agile's actual and reasonable costs of construction for the second MSC to the nearest diverse Agile fiber backbones, not to exceed \$100,000 per new MSC site.
- 2. Agile shall provide all Services to T-Mobile in conformance with the Technical Specifications.
- 3. Agile shall be responsible for its activities relating, but not limited to, the engineering, design, maintenance, operation and monitoring of its network, in accordance with this MSO and the Agreement. This shall include, but not be limited to, zoning, permits, construction and acquisition of Agile lease space.
- 4. Point of demarcation of Carrier service(s) will be in the T-Mobile compound and not in any other location such as easement or Right of Way unless specified by T-Mobile.
- 5. Agile shall provide all tools and test equipment related to the installation, maintenance and operation of its backhaul network, and the Parties will test the Service in accordance with the Acceptance procedures set forth in the Technical Specifications of the BSA.

#### C. Site Backhaul Deployment Schedule.

 For a period not to exceed thirty (30) days from the Effective Date of this MSO ("Design Phase"), T-Mobile and Agile agree to work on a deployment schedule for the deployment of Service to the MSO Sites ("Deployment Schedule"), through a joint design process. The Design Phase includes, without limitation, site walks by both parties at each MSO Site, material review, design layouts, and all other information necessary to ensure timely deployment of the MSO Sites pursuant to the Deployment Schedule. The Deployment Schedule shall provide for the set minimum number of MSO Sites that will be deployed that is equal to or better than the Deployment Commitment. Agile shall deploy Service to the MSO Sites in accordance with the Deployment Schedule, which is subject to the terms and conditions of this MSO and the Agreement (including its addenda). For each MSO Site, Agile will notify T-Mobile in writing of its preferred fully operational capacity date ("FOC Date"). Prior to commencement of any work on an MSO Site, Agile shall request that T-Mobile provide a notice to proceed under this MSO (an "MSO NTP") authorization. Upon issuance of an MSO NTP, the FOC Date will be set to the extent that the MSO NTP does not modify the actual date of the FOC Date by more than thirty (30) days. The parties may mutually agree in writing to the modification of the Deployment Schedule from time to time.

- 2. If any Service is (1) not ready for Acceptance by T-Mobile by the applicable FOC Date, or (2) not ready for Acceptance by T-Mobile across the minimum number of MSO Sites set forth in the Deployment Commitment, then then after 30 calendar days on day 31 Carrier shall credit to T-Mobile an amount equal to one-tenth (1/10) equivalent of the corresponding Monthly Recurring Charge for each calendar day thereafter that the Service is not available; provided, however, that such credit shall be capped at a maximum credit equal to one (1) month's MRC. If an MSO Site is not performing pursuant to the Technical Specifications after Service Commencement Date, then TMobile will have all its rights and remedies as set forth in the Agreement including those relating to Outage Credits.
- 3. Agile will credit this amount to T-Mobile within sixty (60) days of the date on which they were earned.

#### D. Agile Site De-Selection

Subject to the terms and conditions of the Agreement and this MSO, Agile will make commercially reasonable effort to provide Service to one-hundred percent (100%) of the MSO Sites set forth on <u>Exhibit C</u> and fully expects to deliver Ethernet services to such Sites. However, in the event Agile determines that it is unable to provide Service at any MSO Site set forth in <u>Exhibit C</u> and makes such deselection within the Design Phase, T-Mobile may cancel all or any portion of this MSO without further liability.

## E. Reporting Activities

1. Agile will provide a summary project plan derived from detail on a per MSO Site basis every month for the duration of the project through Acceptance outlining the current and future project status. The following items will be included,

- a. Project Start Date
- b. Key Milestones
- c. Fiber
- d. Equipment Procurement/Staging
- e. Equipment Testing
- f. Equipment Installation
- g. Service Testing
- h. Network Activation
- i. Commitment Level Status

2. As MSO Sites are deployed, Agile will provide T-Mobile with mutually agreed upon reports of operational and technical performance of the Service at those MSO Sites, and in aggregate.

F. Additional Site Orders (other than those listed in <u>Exhibit C</u>). At any time, T-Mobile and Agile may agree to have Agile provide Service under the same terms and conditions of this MSO for additional Sites in the Market.

**G. Early Termination**. The following provisions shall apply to an early termination of an MSO Site pursuant to the BSA, notwithstanding the provisions of Section 3.1.1 of the BSA: If T-Mobile cancels all Services to an MSO Site after the Service Commencement Date of such Services, T-Mobile shall pay Carrier an early termination charge that equals:

(i) one hundred percent (100%) of the unpaid, undisputed MRCs due in the initial thirty-six (36) months of the Service Term, if any, plus

(ii) fifty percent (50%) of the unpaid, undisputed MRCs in months thirty-seven (37) through forty-eight (48) of the Service Term, if any, plus

(iii) twenty-five percent (25%) of the unpaid, undisputed MRCs in months forty-nine (49) through sixty (60) of the Service Term.

iv. zero percent (0%) of the unpaid, undisputed MRCs in months sixty-one (61) through

eighty-four (84) of the Service Term. The foregoing shall be Agile's sole and exclusive remedy in case of early cancellation of Service at an MSO Site by T-Mobile.

H. **Miscellaneous.** Unless expressly provided otherwise in this MSO, all terms and conditions of the Agreement (including the BSA) shall apply to the rights and obligations of the parties under this MSO and the Services shall be in all respects governed by the terms and provisions of the Agreement (including the BSA). If there is any conflict or inconsistency in the terms of this MSO and the Agreement (including the BSA), then the terms of the Agreement (including the BSA) shall control.
