- {¶ 1} The Toledo Edison Company (Toledo Edison) is a public utility, pursuant to R.C. 4905.02, and is, therefore, subject to the jurisdiction of this Commission.
- {¶ 2} Pursuant to R.C. 4905.26, the Commission has authority to consider written complaints filed against a public utility by any person or corporation regarding any rate, service, regulation, or practice relating to any service furnished by the public utility that is in any respect unjust, unreasonable, insufficient, or unjustly discriminatory.
- {¶ 3} On January 8, 2018, John Blanchard (Complainant) filed a complaint against Toledo Edison alleging that Toledo Edison improperly disconnected electric service for nonpayment without first providing advanced written notice at the premises and did not provide a reasonable opportunity to dispute the disconnection.
- {¶ 4} On January 26, 2018, Toledo Edison filed its answer to the complaint, denying many of the allegations contained therein. Additionally, Toledo Edison raised several affirmative defenses, including, but not limited to, the following: Complainant fails to set forth reasonable grounds for complaint as required by R.C. 4905.26; Complainant fails to state a claim upon which relief can be granted; and Toledo Edison has complied with all applicable rules, regulations, and orders of the Commission, and its tariffs. Additionally, Toledo Edison requested that the Commission dismiss the complaint.

[¶ 6] On August 1, 2018, Mr. Blanchard filed a motion to compel discovery.
