On August 13, 2018, the Complainant filed an application for Rehearing on the Second Entry on Rehearing pursuant to R.C. 4903.10. R.C. 4903.10 provides for the filing of an application for reheating in respect to any matters determined in the proceedings. To the extent complainant seeks to appeal the orders of the PUCO to the Ohio State Supreme Court, affecting his legal right to receive a written disconnection notice at the premises in a conspicuoius location prior to the disconnection as required by Ohio Adm. Code 4901:1-18-06(A)(2). To the extent, the complainant has met his burden of proof relative to the allegations regarding Columbia's failure to provide a disconnection notice at the premises on the date of disconnection that should have been provided or disconnected the next day. Complainant's August 13, 2018, application for Rehearing on the Second Entry on Rehearing, in this case, should be granted on the basis that Columbia is still not in compliance with the PUCO's Rules concerning termination of complainant's natural gas service pursuant to Ohio Adm. Code 4901:1-18-06(A)(2).

An emergency hearing is deemed necessary in this case due to the complainant is undergoing severe financial hardship due to a shut-off notice of his natural gas service. (see attached disconnection notice, dated 09/05/2018). Notwithstanding the PUCO's Winter Reconnect Order which is from October 15, 2018 through April 15, 2019, complainant asserts that an emergency hearing on his application for Rehearing on the Second Entry on Rehearing pursuant to R.C. 4903.10, filed herein on August 13, 2018, can potentially resolve the financial hardship. Accordingly, the complainant request an immediate hearing on his claim that Columbia is still not in compliance with the PUCO's Rules concerning termination of complainant's natural gas service pursuant to Ohio Adm. Code 4901:1-18-06(A)(2).


