#### MEMORANDUM IN SUPPORT

Republic Steel filed the Complaint in this matter on October 11, 2017.<sup>2</sup> AEP Ohio filed its Answer to the Complaint on November 13, 2017.<sup>3</sup> A settlement conference was held on February 1, 2018,<sup>4</sup> and a procedural schedule was established on April 30, 2018.<sup>5</sup> Pursuant to the established procedural schedule, testimony is currently due on September 28, 2018,<sup>6</sup> and the hearing is to commence on October 9, 2018.<sup>7</sup>

The Parties have been engaged in settlement discussions in an attempt to resolve this case, and recently some progress has been made. In order to more fully pursue a settlement, the Parties require additional time to continue these discussions and explore available options for a mutually agreeable resolution of this matter. As such, the Parties respectfully request that the Commission continue the procedural schedule in this matter

until a date established by subsequent entry. The Parties also request that the Commission schedule a status conference to update the Commission on the settlement discussions two months from the date that the hearing in this case is currently scheduled to begin.

Ohio Adm. Code 4901-1-13 provides that the Commission may grant continuances of hearings for good cause shown. Here, the parties submit that the need to continue settlement discussions serves as good cause to continue the procedural schedule as requested herein.

The Parties additionally request that the Commission consider this motion on an expedited basis pursuant to Ohio Adm. Code 4901-1-12(C). No party opposes expedited consideration of this motion.
