MOTION FOR EXTENSION

Pursuant to Ohio Administrative Code Rule 4901:1-27-09(B), Navigate Power, LLC (“Navigate Power”) seeks an extension of Certificate No. 16-546G (1), which was issued in Case No. 16-1861-GA-AGG with an expiration date of October 9, 2018. Due to the press of other business, Navigate Power was not able to file its renewal application on time. It filed its Renewal Application on September 26, 2018, which was twelve calendar days prior to the October 9, 2018 expiration date. In support of the application, Navigate Power respectfully requests that Certificate No. 16-546G (1) be automatically extended from October 9, 2018 until November 9, 2018 or until the date that the renewal certificate is issued.

WHEREFORE, Navigate Power respectfully requests that Certificate No. 16-546G (1) be automatically extended to November 9, 2018 or until a renewal certificate is issued and authorize it to continue to operate during the pendency of the renewal application certification review

**MEMORANDUM IN SUPPORT OF
MOTION FOR EXTENSION**

Due to the press of other business, Navigate Power did not meet the September 9, 2018 filing date for its Renewal Application in Case No. 16-1861-GA-AGG. Navigate Power sincerely apologizes for the delay and emphasizes its desire to continue to serve customers in Ohio. A Renewal Application was filed on September 26, 2018, however a Motion for Extension was mistakenly not filed along with it. Navigate Power, LLC is filing that motion as it previously should have to allow for the extension during the renewal review, which is ongoing.

Ohio Administrative Code Rule 4901:1-27-09(B) provides that a motion requesting an extension of a certificate will be deemed automatically approved (unless ruled otherwise by the Commission or an Attorney Examiner within three business days), if a renewal application is filed fewer than thirty calendar days prior to the expiration date of the certificate but no later than the expiration date. Navigate Power submits that it has met the criteria and respectfully requests an automatic extension of the expiration date of Certificate No. 16-546G (1) issued in Case No. 16-1861-GA-AGG to November 9, 2018, or until such time as a renewal certificate is issued.
