Dear Ms. McNeal:

Pursuant to Ohio Adm.Code 4906-3-03(A), Nestlewood Solar I LLC, an affiliate of Lendlease Energy Development LLC, files this Pre-Application Notification Letter regarding its proposed 80 MW solar electric generating facility in Clark Township, Brown County, Ohio and Tate Township, Clermont County, Ohio with the Ohio Power Siting Board.

The proposed 80 MW solar electric generating facility will be located within approximately 610 acres of privately owned land approximately 3 miles west of Hamersville, Ohio. The purpose of the project will be to generate electricity and interconnect with the regional transmission grid to supply the region with power. Construction of the facility is expected to commence during the second quarter of 2019. The project is scheduled to be in service by the second quarter of 2020.

The public informational meeting will be held from 6:00 p.m. to 8:00 p.m. on Wednesday, November 7, 2018 at the Hamersville Elementary and Middle School, 1950 State Route 125, Hamersville, OH 45130.

At this time, the Applicant anticipates requesting a waiver from Ohio Adm.Code 4906-4-08(A)(1)(c) to allow it to provide manufacturer's safety information as part of the final construction plans for the facility. Applicant also anticipates requesting a waiver from Ohio Adm.Code 4906-4-08(A)(5)(c) to allow it to submit plans for geological test borings in advance of the commencement of field work.
