OHIO POWER COMPANY'S AMENDED NOTICE OF ADDITIONAL WITNESSES

The Attorney Examiner issued an Entry in these cases on October 22, 2018 that, among other things, granted consolidation of the above-captioned cases and issued a procedural schedule for the first phase of evidentiary hearings. Paragraph 32 of the Entry indicated that the bifurcated hearing process does not preclude Ohio Power Company ("AEP Ohio" or the "Company") from offering its direct testimony, as submitted in support of the application in the *Tariff Cases*,¹ at the hearing on the issue of need. The Company evaluated this option and filed a Notice of Additional Witnesses in this docket on October 26, 2018, which contained the following sentence: "The economic impact study, as a supplement to the Long-Term Forecast Report Amendment and supporting testimony filed on September 27, 2018 in the *LTFR Case*, will provide additional evidence of the need for renewable projects being addressed in these consolidated cases and will assist the Commission in developing a complete record to decide that issue." The reference to the Company's supporting testimony in the *LTFR Case* erroneously

recited the filing date as September 27, 2018 when September 19, 2018 is actually the correct filing date for the Company's supporting testimony in the *LTFR Case*.

To eliminate any confusion about the original intent of the Company's October 26, 2018 Notice, this Amended Notice is being filed to clarify that the Company plans to call AEP Ohio witness Dr. Buser and AEP Ohio witness LaFayette as witnesses in the scheduled evidentiary hearing in addition to the original witnesses that filed supporting testimony in the *LTFR Case* on September 19, 2018.
