

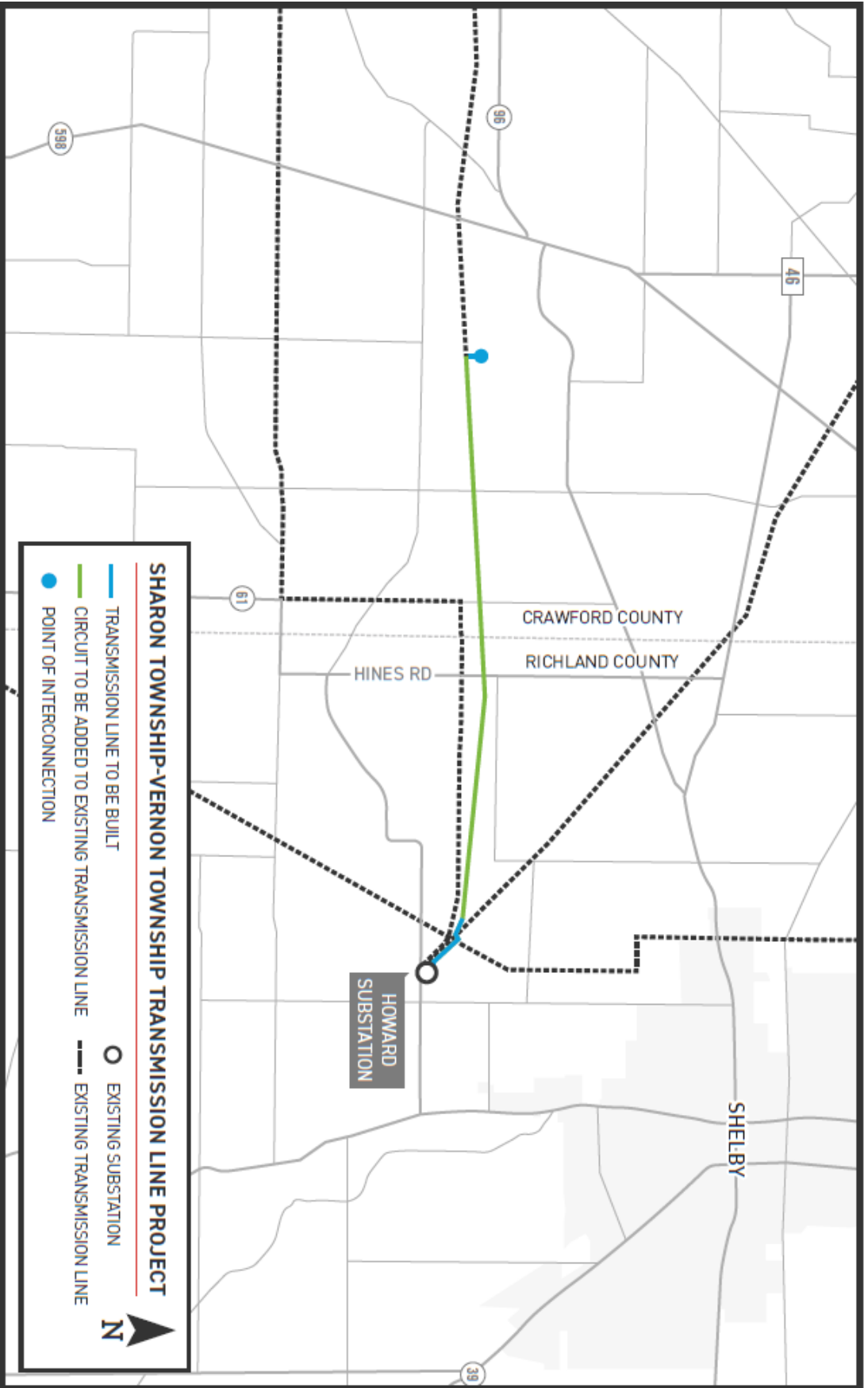

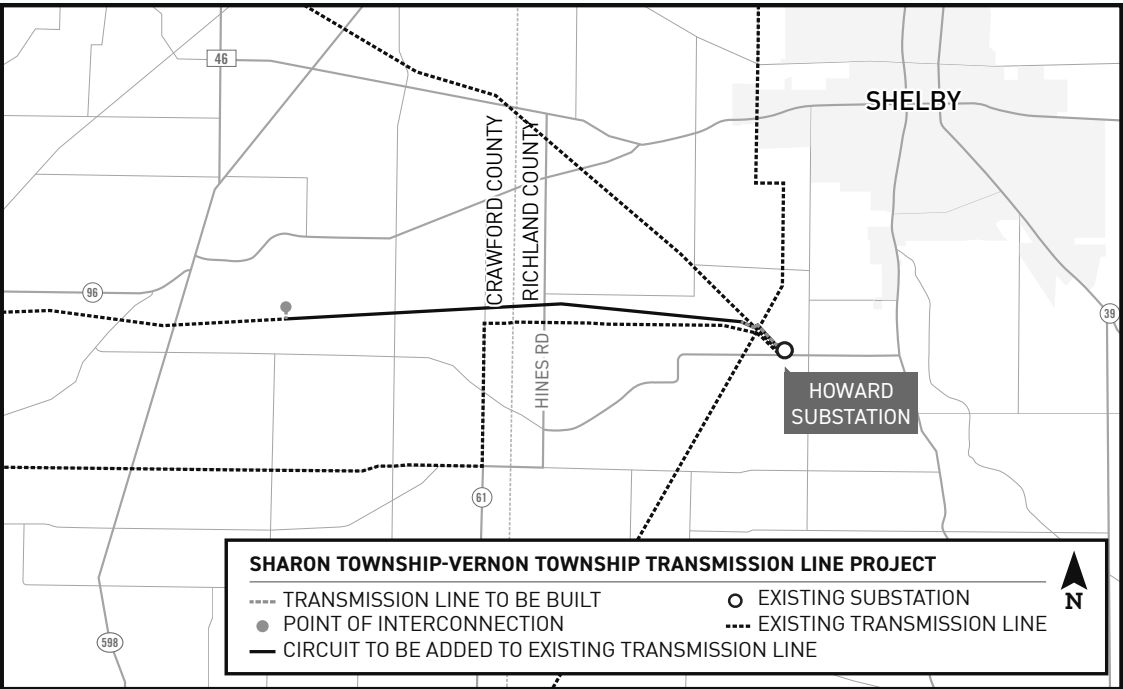

RICHLAND COUNTY — Bruce Phipps, Commander of the Richland County Joint Veterans Counsel announced an American flag would be raised on Thursday, Oct 11, 2018 in front of the Richland County courthouse at 6:00 p.m. to honor 4 deceased Richland County brothers: James G. Dillon, Harry J. Dillon, Paul E Dillon and Robert A. Dillon.

James Glen Dillon served in the US Army from Oct 27, 1941 to Oct 10 1945 serving as an Antiaircraft Arty Crewman earning the rank of Sgt. E-5. James was born April 22, 1918 and died July 9, 2001 and is buried in Mansfield Catholic Cemetery.

Robert A. ‘Red’ Dillon served in World War II with the US Army-Air Force from 11 June 1942 to 16 Feb 1946 serving as a Radio Operator and Mechanic. Robert was born Oct 1, 1920 and died Feb 2, 2006 and buried in the Mansfield Catholic Cemetery.

Paul Eugene ‘Gene’ Dillon served in the US Army from Mar 11, 1943 to Jan 30, 1946 serving as a certified parachutist in the 1530th Airborne Anti-Aircraft Battalion & earning the rank of Sergeant.

Paul was born Nov 19, 1922 and died Jan 9, 2001 and buried in Mansfield Cemetery.

Harry Joseph Dillion a retiree of the US Army with 20 years, serving from Sept 26, 1949 to Mar 1, 1970. He was also Seaman First Class in the US Navy during WWII. Harry served in WWII, Korean and Vietnam Wars & was a recipient of a Purple Heart. Harry was born July 3, 1929 and died April 23, 1994 and is buried in Mansfield Catholic Cemetery.

The brothers were the sons of Paul D and Virtlee O’Hearn Dillon.

The Honored Veteran’s Flag will be flown for 21 days at the Richland County Administration Building after which the Veteran’s name will be engraved on a brass name plate and added to a plaque listing those veteran’s honored in the same manner already displayed on the wall in the foyer of the Richland County Administration Building.

The Joint Veterans Council of Richland County operates the flag program.

\$28 for adults; \$25 for groups of 10 or more; and \$18 for children under 12.

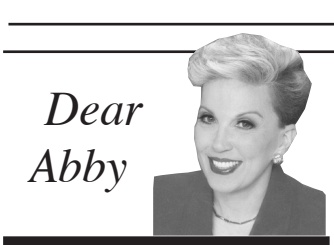
